Thanks for choosing our LiPo Battery pack. If you have any problems, questions, or concerns about this product, please contact us. Please carefully read all the instructions and precautions before use.

**Terms of use**: The buyer assumes all risks associated with LiPo batteries by using this product. FXR Factory Racing, its affiliates, manufacture's, distributors, and retail partners cannot control the use, charging, installation, and application of this or any LiPo battery and therefore shall not be held responsible for any accident or injury to any person and/or property damage in resulting from the use of any LiPo battery. If after reading all the instructions, warnings, and information provided, you are not ready to accept full liability for using and charging this LiPo battery, please return it unused in perfect condition with all packaging. No returns are allowed after use unless there is an approved manufacture defect. All defective returns MUST be approved by FXR within the 6-month warranty period.

# **BEFORE CHARGING:**

- •Please read the instructions before charging.
- •Always check the battery before charging for any type of damage. Check the battery packaging, wires, and connectors for defects which may cause a short circuit and eventual battery failure.
- Make sure you are using the specified charger.
- •Always verify the charger is in good condition. A poor-quality charger can be dangerous.
- •It is solely your responsibility to assure that the charger you use works properly. Always monitor the charging process to assure batteries are being charged properly. Failure to do so may result in a fire.

# CHARGING:

- •Only use the specified charger. Do not use NIMH/NICD/LIFEPO4/LEAD ACID charger. Failure to do so may cause a fire, which may result in personal injury and property damage.
- •Never charge battery inside the garment.
- •Never overcharge batteries beyond the capacity listed on the labels.
- •Never overcharge batteries over their rated maximum voltage (4.35/cell for LiPo).
- •When charging, please make sure the surroundings are clean. Always place the batteries in a LiPo charging bag or a fire retardant/fireproof container and on a non-flammable surface such as concrete. Don't charge without monitoring to ensure the charging safety. Stop charging in a timely matter when the battery is fully charged. Do not connect the charger and battery for a long time when the battery is fully charged. We will not be responsible for any personal injury and property lost or any kind of accident that is caused by improper charging.

# STORAGE:

- •Do not directly connect the terminals to metal objects. This will short-circuit the battery, resulting in heat and possibly explosion.
- •Never store batteries in a compartment of a machine; example glove box or saddle bag.
- •When transporting batteries, you should use an approved LiPo charge bag or a non-conductive and fireproof container.
- •Never leave batteries to extreme temperatures or direct sunlight. The batteries should be stored within 10 C° 45C° range environmental condition. If the battery must be stored for a long time (Over 3 months), the environmental condition should be:
- •Temperature: 23 C° Humidity: 65 ± 20%RH
- Always disconnect batteries when not in use
- •Never store the batteries in your heated gloves, storage compartments or any garments. Always store batteries in a LiPo charging bag or in a non-conductive and fireproof container.
- •Never alter, puncture, or impact batteries or related components.

## SAFETY:

- •Never strike battery with any sharp edge materials
- •Never open or deform folding edge of the cell
- •Never drop, hit bend battery cell body
- •Never disassemble the cells. The disassembling may generate internal short circuit in the cell, which may cause gassing, firing, or other problems.

- LiPo battery should not have liquid electrolyte flowing from cells. In case the electrolytes contact the skin, or eyes, flush the electrolyte immediately with fresh water and seek medical attention.
- •Never incinerate dispose of the cells in fire. This may cause firing of the cells, which is very dangerous and is prohibited. The cells shall never be soaked with liquids such as water, coffee, juice, or any type of liquids.
- •The cells might become damaged during transportation by shock. If abnormal features of the cells are found such as damages in the shrink wrap of the cell, deformation of the cell package, smelling of electrolyte, electrolyte leakage and others, the battery shall never be used any more. The cells with a smell of electrolyte or a leakage shall be placed away from fire to avoid firing.
- If at any time the battery becomes damaged, hot or begins to balloon or swell, discontinue charging or unplug from garment immediately. Then place the battery and/or charger in a safe, open area, away from flammable materials inside a fireproof container (such as a LiPo Charge Bag). After one hour, if the battery condition has stabilized, remove the battery from service. Do not continue to handle, attempt to use, or ship the battery. Failure to follow these procedures can cause damage to the battery, personal property or cause serious injury.
