Release and Waiver of Liability Form, Assumption of Risk and Indemnity of Agreement ("Agreement")

By signing this document you will waive certain legal rights, including the right to sue.

- 1) I, the undersigned, wish to play Airsoft, I recognize and understand that playing Airsoft (hereinafter called the "Game") involves certain risks. Those risks include, but not limited to, the risk of injury resulting from possible malfunction of the equipment used in the Game and injuries resulting from tripping or falling over obstacles in the Game playing field. In addition, I recognize that the exertion of playing the game could result in injury or death.
- 2) Despite these and other risks, and fully understanding such risks, I wish to play the Game and hereby assume the risks of playing the Game. I also hereby hold harmless Vanwell Distribution Services/Niagara Quartermaster and its Employees (hereinafter called the "Sponsors") and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including legal fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Game, including without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of any and all equipment used in the Game. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I am in good health, not under the influence of any intoxicating substances and do not suffer from a heart condition or any other ailment which could be exacerbated by the exertion involved in playing the Game. I further certify that I am at least 18 years of age or I am the parent or legal guardian of the player of the Game and I agree to the next paragraph 3.
- 3) If the applicant is less than 18 years of age, the parents or guardians must execute the following release of liability, waiver of claims and indemnity agreement. The undersigned parent or parent having sole custody, or legal guardian, does hereby represent that he or she is, in fact, acting in such capacity, and agrees to save and hold harmless and indemnify each and all the Sponsors and Releasees referred to in this document from all liability, loss, cost, claim or damage whatsoever that may be imposed upon said parties because of any defect in or the lack of the minor's capacity to so act, and I release the said parties on behalf of both the minor and the parents or legal guardian.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:

In consideration of myself or my child if younger than 18 years old participating in the Game, I hereby agree as follows:

- 1) TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against VANWELL DISTRIBUTION SERVICES/NIAGARA QUARTERMASTER, their directors, officers, employees, agents, Sponsors and representatives (all of whom are hereinafter collectively referred to as "the Releasees");
