
How to use your Blynclight Wireless


Charging your Blynclight

Connect the provided USB cable from your PC to the Blynclight to charge the device. The indicator at the front of the device will show a solid red light while charging. Once fully charged, around 2.5 hours, the red indicator will switch off. When operating the device wirelessly, the front indicator will display a solid green light. When the device requires charge, the front indicator will begin flashing green.

Connecting your Blynclight

Plug the USB wireless adaptor into the USB port of your PC. Beneath the Blynclight, push the switch into the 'On' position.





Download Embrava Connect software

To activate the Blynclight, download and install the Embrava Connect software at http://www.embrava.com/software.

Setting your Availability

With Embrava Connect installed and running, the Blynclight will automatically display the color matching your selected UC application status. 



Mounting your Blynclight

Select a position to mount your device that is within 30 feet of the PC with the wireless adaptor connected. (Operating distance may vary if interrupted by walls.)

Clean and dry the surface you wish to apply the mount. Peel one side of the included 3M adhesive and apply it to the rear of the mount. Peel the other side of the 3M adhesive and apply to the cleaned surface with pressure for around 10 seconds. Slide your Blynclight down onto the mount to lock it in position. Sliding the device up will release the device





Uploading Ringtones

Connect the provided USB cable from your PC to the Blynclight and turn the Blynclight on via the switch on its base. You will now see a storage device appear within your PC.

To play your own ringtones on the device, copy and paste your mp3 ringtones onto this storage device. Use Embrava Connect to configure which ringtones should play for certain events.

Limited Warranty Statement
