- Rinse empty container three times with a volume of water equal to a minimum of 10 % of that of the container. Add the rinsings to that of the spray tank.

If Neudosan gets into your eyes, hold eye open and rinse slowly and gently with water for 10 minutes.

DIRECTIONS FOR USE: (use only as directed).

- Shake container before use.
- Add sufficient water to tank and then add NEUDOSAN, continue with agitation while adding additional water. Spray solution should be used within several hours of preparation.
- NEUDOSAN is suitable for both indoor and outdoor use.
- Apply in the coolest part of the day, morning or evening.

COMPATIBILITY:

Physical compatibility should first be checked by mixing the recommended dosages of the products in a small jar test. Then test the spray tank mix combinations for phytotoxicity on a sample of crops prior to use. Do not apply in temperatures above 30° C.
