## FULL-SIZE CAKES

$6^{\prime \prime}$ round x $3^{\prime \prime}$ tall (serves 8-12) ..... \$75
$9^{\prime \prime}$ round $\times 3^{\prime \prime}$ tall (serves 14-18) ..... \$115
$9^{\prime \prime}$ square $\times 2.5^{\prime \prime}$ tall (serves 20-25) ..... \$130
$12^{\prime \prime}$ round $\times 3^{\prime \prime}$ tall (serves 40-50) ..... \$210
$12^{\prime \prime} \times 18^{\prime \prime} \times 2$ " sheet (serves 55-75) ..... \$300

Up to four tiers can be combined; pricing for stacked cakes will reflect the sum of the tiers' prices plus a $\$ 25$ construction and boxing fee. Stacked tiers are separated by cardboard cake plates and should be taken apart for serving.
Cake toppers, special cake plates, and other purchased decorations can be added for a \$10 handling fee.

Dry ice is available at $\$ 20$ per 10 lbs .; delivery is available starting at $\$ 30$. The amount of dry ice and delivery fees will depend on the delivery distance, the size of the cake, and the amount of time the cake will be out of a freezer. Ice cream can be held on dry ice for up to 48 hours.

## POLICIES

Wedding cakes and desserts must be ordered with at least one month's advance notice.

A tasting of selected ice cream flavors, baked goods, frostings, and decorations can be arranged for a fee of $\$ 60$ (not including delivery) before the order is placed. A deposit of $50 \%$, minus any previously paid tasting fee, is due on the order date. Any remaining balance is due one week before the wedding date.
Bartleby's must be given the contact information of the wedding planner or venue manager at least two weeks before the event in order to make arrangements for cake delivery, storage, and serving.

Bartleby's is responsible for the condition of the ice cream through the time of pickup or delivery only. Storage and serving on site are the responsibility of the wedding couple and serving staff; Bartleby's will provide suggestions on how to preserve the condition of the ice cream but is not responsible for any melting or other damage that occurs after delivery.
