Aloe Futures—A Footnote

There is no way to complete the story of Aloe Vera because it continues to build, daily. Even as we write this, new data pours in verifying its remarkable potentials through letters of testimony, explorations into new uses, and new experiments to obtain even greater levels of credibility for this Silent Healer.

Recently, we have underwritten a series of double-blind studies to be conducted by an independent research dermatologist. This is being done to determine and re-establish both its true healing potentials and its lack of measureable toxicity. Other *in situ* studies are being conducted at medical clinics using our Stabilized* Aloe Vera products on patients in various conditions of dermatological trauma. These, we hope, will reaffirm much of what we have already found and strengthen the objectives we believe in so strongly.

Other objectives, we fear, are still beyond our grasp.

There is to date no sure way to measure the total beneficial effect our Stabilized* Aloe Vera Gel has reaped when taken internally in the human system. Even the most courageous physicians are reluctant to use the gel systemically on any but the most extreme cases (even though some of these physicians have used the gel personally for many years).

Through our studies of case histories we have reason to believe the systemic potentials of Stabilized* Aloe Vera may someday prove to be its strongest asset. We are working diligently to bring that evidence to bear and clinically give it credence.

We also doubt that all the mysteries of the wonderful chemistry of Aloe Vera will be resolved in our lifetime. So much remains to be answered. It will take generations of work to put all the pieces in place; and perhaps that is as it should be. We have done what we could, here, to help light the way.
