CARAMELLO SALATO

Appearance

Flowing powder of light beige color, with the characteristic flavor and aroma of caramel.

Characteristics

Product description

Semi-processed powder that creates a unique combination between the sweetness of caramelized milk and the strong character of salt in ice cream. The flavor was inspired by the tradition of French pastries. The two tastes of caramel and salt blend very well and may be emphasised differently depending on the ingredients used (e.g. addition of fresh cream). The ice cream can be variegated with Variegato Fleur de Sel, Caramelo Variegate and with fillings, cookies or crumbled shortbread.

List of ingredients

sugar, refined vegetable fats (coconut), skimmed milk powder, glucose syrup, lactose, dextrose, milk proteins, colors: plain caramel, annatto; emulsifiers: glyceril-lacto esters of fatty acids, mono- and diglycerides, propylene glycol mono- and diesters of fatty acids; malt dextrines, table salt, stabilizer: tara gum; natural and artificial flavors.

Dose and use instructions

Directions for use: 400 g of product, 1 liter of milk. 1 bag of 1000g for 2,5 liter milk. Cold processing. We suggest having the mix rest for 20-30 minutes.

Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 24 months since the production date. The "best before" term is printed on each package.

General requirements

This product complies with the current Italian and European Community (EC) laws concerning its use.

Ingredients are either FDA approved as food additives or listed or affirmed as GRAS. If listed, only FDA batch certified Color additives are used.
