Appearance

Smooth, white coloured powder.

Characteristics

Semi-finished product in powder excellently soluble even in cold, ready to be used by adding water only (already provided with sugar, thickeners and stabilisers). It is used to prepare sorbetti or ice creams with the typical flavour of the lemon liqueur named "Limoncello". It ensures an easy processing, a smooth texture, an excellent preservation for several days, a satisfactory volume increase and a fresh and strong lemon and lemon rinds aroma, never too acid.

"SDL products: products without milk or milk by-products."

List of ingredients

Sugar, dextrose, glucose syrup, refined vegetable fats (coconut), concentrated dehydrated lemon juice, natural and artificial flavors, stabilizers: tara gum, hydroxypropyl methylcellulose; acidifier: citric acid; emulsifiers: glyceril-lacto esters of fatty acids, propylene glycol mono- & di- esters of fats & fatty acids; corn food starch-modified, vegetal proteins (SOYA), vegetal fibre (oligofructose), color: riboflavin.

May contain: MILK, EGGS, ALMONDS, HAZELNUTS, WALNUTS, CASHEW NUTS, PISTACHIOS.

Packaging

39,0 x 29,3 x 26,0 cm carton including 12 thermal-sealed bags in MET PET – PE multilayer film.

Bag size: H: min 300 mm max 380mm; W: 206mm

Bag net weight: 1,350 kg. Net weight: 16,2 kg.

Dose and use instructions

450 g of product per 1 litre of water. Cold processing: dissolve 1 pack (1,350 kg) in 3 litres of water. Let the mix rest for 20/30 minutes before you put it in the batch freezer.

For an even stronger lemon aroma, you can replace some water with lemon juice. If you desire a slightly alcoholic ice cream, add 15-20 cc of Limonito liqueur after icing.

Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 24 months since the production date. The "best before" term is printed on each package.

General requirements

This product complies with the current Italian and European Community (EC) laws concerning its use.

Ingredients are either FDA approved as food additives or listed or affirmed as GRAS. If listed, only FDA batch certified Color additives are used.
