Flowing powder of light yellow color, with intense scent of peach.

Characteristics

Semifinished product in powder, ready to be used, featuring a high content of dehydrated peach pulp and for the remarkable scent and aroma of yellow peach. It is ideal to prepare, simply and quickly excellent peach ice creams or sorbetti or speciality cups like 'Pesca Melba'. Can be used also to prepare slushes with creamy structure as well as in soft ice machines processing.

List of ingredients

Sugar, dextrose, fully hydrogenated vegetable fats (coconut), dehydrated glucose syrup, dehydrated peach, corn starch, emulsifiers: acetylated monoglycerides, glyceril-lacto esters of fatty acids, sucrose fatty acid esters; milk proteins, stabilizer: locust bean gum; acidifier: citric acid; natural and artificial flavors, colors: riboflavin, beta-carotene.

Dose and use instructions

450 g of product per litre of water. Cold processing Let the mixture rest for at least 30 minutes The ice cream can be customised replacing with lemon juice some of the water

(e.g. 10/20 g for litre), in order to emphasise of the sour taste. For a creamier ice cream, part of the water can be replaced with pasteurised milk (e.g. half water and half milk).

Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 24 months since the production date. The "best before" term is printed on each package.

General requirements

This product complies with the current Italian and European Community (EC) laws concerning its use.

Ingredients are either FDA approved as food additives or listed or affirmed as GRAS. If listed, only FDA batch certified Color additives are used.
