#### **Product description**

Appearance

White coloured smooth powder, with lemon smell and slightly sourish lemon flavour.

Characteristics

It is a complete product suitable to prepare excellent lemon sorbets characterised by a creamy texture with top hold in the showcase and clean flavour with outstanding juice hint. The gelato you prepare with the suggested recipe does not contain: milk and milk by-products, egg by-products, gluten, hydrogenated vegetable fats (it contains refined fats). "SDL products: products without milk or milk by-products."

#### List of ingredients

Sugar, dextrose, glucose syrup, refined vegetable fats (coconut), concentrated dehydrated lemon juice, acidifier: citric acid; malt dextrines, stabilizers: tara gum, hydroxypropyl methylcellulose; natural and artificial flavors, emulsifiers: glyceril-lacto esters of fatty acids, propylene glycol mono- and diesters of fatty acids; vegetal proteins (pea, soya), vegetal fibre (oligofructose). May contain: MILK, EGGS, ALMONDS, HAZELNUTS, WALNUTS, CASHEW NUTS, PISTACHIOS.

#### **Packaging**

39,0 x 29,3 x 26,0 cm carton including 12 thermal-sealed bags in MET PET – PE multilayer film.

#### Dose and use instructions

450 g of product with 1 liter water

For a more intense lemon flavour, a quantity of water (for ex. 100 ml) can be substituted with same quantity of lemon juice. Cold processing.

Disperse the content of a bag in 3 liters of water.

Let the mix rest for approx. 30 minutes. Then process.

### Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 24 months since the production date. The "best before" term is printed on each package.

### **General requirements**

This product complies with the current Italian and European Community (EC) laws concerning its use. Ingredients are either FDA approved as food additives or listed or affirmed as GRAS. If listed, only FDA batch certified Color additives are used.
