Dose and use instructions

410 g of product with one litre of water.For a more intense tangerine flavour, you can replace some water (e.g. 10%) with an equal amount of tangerine juice.Cold processing.Dissolve the contents of a bag in 2.5 litres of water.Allow the mixture to rest for about 30 minutes. Then stir.

Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 24 months since the production date. The "best before" term is printed on each package
