Ivory-white colored preparation containing grated coconut pulp.

Characteristic

Semi-finished product in paste, characterized by the presence of natural flavors only and the considerable content of coconut pulp. It is ideal for the preparation of coconut flavoured gelato, pure or in combination with fresh or frozen fruit. It can also be used to prepare slushes and other pastry recipes.

Sugar, glucose syrup, dried coconut, water, natural flavors.

Dose and use instructions

100 g of product per liter of base mix prepared with milk only or with milk and water. In varying quantities in addition to fresh fruit.

Stir well before use.

Storage

The product, stored in the original sealed container, in a cool and dry place, will keep its original features unchanged for at least 24 months since the production date. The "best before" term is printed on each package.

General requirements
