Key features of the BPP Enhanced Classroom product

• Recorded lectures

Your learning content is broken into syllabus topics. The recorded lectures, which can be viewed at any time, help you to understand and apply the syllabus content by either explaining a concept, showing you a worked example, or providing you with an opportunity to apply the concept yourself. The lectures follow the BPP Course Notes.

Assessment activities

The online assessments and further question practice activities will help you identify your strengths and weaknesses on specific areas, demonstrate learning of the core syllabus knowledge and provide you with lots of opportunity to practice and include real life examples. You can attempt some of the assessments as many times as you wish, and feedback is provided on each answer you provide.

Updates & Announcements forum

In the Forums area you will see Updates & Announcements – this provides information such as when the Hub will be unavailable, and for how long, due to scheduled maintenance. We recommend that you check this forum on a regular basis.

How to log in to the BPP Hub.

You will receive a 'trigger' email to activate your account from 'hubwelcome@BPP.com' (note you may find this in your email 'junk' folder). All subsequent courses will be accessed via the same online account, so we recommend you take careful note of your login details. Once you have triggered your account, follow the below steps:

Studying for SBL

We have structured this guidance so that you have a good idea of how much work you should be doing in preparation for each Step assessment. However, we recognise that everyone studies at different speeds, so you will need to ensure that any targets you set yourself are realistic.

How to study via ECR

Your aim is to work through your BPP Workbook along with the recorded lectures and online assessments in the Enhanced Classroom online content. The Workbook you have been provided with should be annotated as you work through the material, and the lecture examples should be completed.

In order to work through the Workbook, we recommend you can use the following method:

• Listen to the recorded lectures in full and annotate the Workbook as you go;

• For lecture examples, have a go at them and if you find them easy, just use the answer at the back of the Workbook to check your understanding. If you have struggled with the lecture example, then use the recorded lectures to go through the theory and the answers in more detail.

The guidance below will give you some pointers as to which areas to prioritise. Try to cover the topics and activities in the guidance in the order shown. Before you start the next day of study, attempt any homework and recap any areas you have struggled with.

Errata

Taught Phase

The emphasis of this first stage is studying the syllabus and gaining the knowledge required to attempt exam questions. During this stage you will work through each chapter of the Strategic Business Leader (SBL) Workbook and steps 1-6 of the Achievement Ladder.

Revision Phase

During this stage the emphasis is on practising exam-standard questions to learn how to apply your knowledge and develop your exam.

Final Preparation Phase

The aim here is to bring all of your skills and knowledge together in a final self-marked mock exam: Step 8 of the Achievement Ladder.

The Hub contains all the information, documents and videos for your course. The different phases of your course are clearly identified in different steps so you can easily find them.

Before you begin the Taught Phase, please take some time looking at the information provided in the **Introduction** section, in particular:

- Watch the Introduction to Strategic Business Leader and How to study and pass video.
- Review the ACCA SBL Support Resources and the ACCA Practical Experience Requirement (PER) Support
- Take the ACCA's ethics and professional skills module (EPSM) if you have not already done so.
- To help remind you of the core knowledge that SBL is based on, work through the resources within 'Step 0 Assumed knowledge'.



Taught Phase



This guidance will take you through the Taught Phase of your course. The emphasis of the Taught Phase is on gaining the knowledge and beginning to develop the skills in order to attempt exam questions. During this Phase you will work through the SBL Workbook, using the online lectures to guide you. You will also work through Steps 1-6 of the Achievement Ladder. The Taught Phase is divided into 6 Achievement Ladder Steps, when you have covered all the chapters in that step, you should attempt the relevant Achievement Ladder Step.

 Key areas Principal-agent relationship in corporate governance Stakeholders (in particular stakeholder power and interest) Social responsibility and corporate citizenship Sustainability (including Integrated reporting <ir>)</ir> Issues relating to corporate governance, stakeholder power and interest, social responsibility and sustainability are the focus of this chapter. You should aim to reinforce your learning by attempting the Activities. Activity 1 addresses agency, and Activity 2 focuses on stakeholders. Activity 3 provides you with an opportunity to apply your knowledge of Mendelow's matrix to a longer, scenario style question. Activities 4 and 5 focus on the important topic of corporate social responsibility. When attempting the Activities, it is important that you pay careful attention to the ACCA Professional Skill which is being tested, for example in Activity 4, which is testing your communication skills, make sure that as well as demonstrating your technical skills you also use the required format of one presentation slide and accompanying notes.

Understanding the different roles played by the executive and non- executive directors and the various types of committees which exist are important. It is important not to overlook the important role that governance plays in public sector organisations as well. There are five Activities in this chapter. You are strongly advised to take the time to attempt these.

As this case illustrates failure to consider changes in the external environment can cause even the most successful companies to struggle. The focus of the next three chapters is upon understanding the importance of the external environment, as well as the internal resources, capabilities and competences that organisations need to be successful.

 Key areas The macro-environment of an organisation, including PESTEL The concept of strategic drift Porter's Diamond Porter's five forces framework Scenario planning 	
Some of the themes covered in this chapter were covered in ACCA Accountant in Business. If you were exempt from Accountant in Business or sat this exam a long time ago, you may like to refresh your memory by listening to 'The Business Environment' Online Lecture in the Assumed Knowledge section before listening to the Strategic Business Leader Online Lecture for Chapter 4. The focus of Chapter 4 covers the important topic of the external environment. In the Strategic Business Leader exam when asked to analyse the external environment of the organisation featured in the question you may, on occasions, need to make a judgement call whether or not to use an appropriate model or theory when structuring your answer. This chapter contains three important models which you may find helpful when structuring your answer: PESTEL analysis, Porter's Diamond, and Porter's five forces framework. It is important to note that you are advised to only use models which you judge as being relevant in answering a particular task. Activity 1 tests the ACCA Professional Skill of analysis in the use of Porter's Diamond and Activity 3 tests Porter's five forces Activity 4 tests the ACCA Professional Skill of commercial acumen. You are strongly advised to take the time to attempt all of the activities.

 Key areas Different types of resources and competences The concept of sustainable competitive advantage Porter's value chain SWOT analysis Chapter 5 is focused on the concept of strategic capability. Understanding the important role that resources and competences play in the creation of strategic capability is very important. Porter's value chain provides a useful framework for assessing the activities of an organisation. As such you are advised to learn the key components of the model as this may assist you when structuring your answer to exam questions. You should aim to attempt Activities 2 and 3 as these both focus on analysis in the context of two very different types of organisation, in addition to testing two of the five ACCA Professional Skills. Another important model which you need to be familiar with is SWOT analysis. SWOT brings together internal and external analyse. Activity 4 provides an opportunity to apply your understanding of strengths and weaknesses to a fashion company. Make sure you present your answers in the format required, for example a report in Activity 4. There are marks allocated for using the correct format in the exam.

As such you are advised to study the material covered here thoroughly. Having considered internal strengths and weaknesses, and external opportunities and threats in the last two chapters, chapter 6 moves on to discuss the strategic choices available to organisations. The aim for organisations is to make the right strategic choices to enable them to create a sustainable competitive advantage. The BCG matrix, Ansoff's matrix, methods of development, and the SFA's are key areas. Activity 2 provides an opportunity to apply your understanding of the BCG matrix to a longer form question. The activity tests the ACCA Professional Skill of commercial acumen in the context of analysing three companies. You should take the time to attempt this activity fully. Activity 3 focuses on a proposal to develop the business of a cloth and clothes manufacturer. This activity tests the ACCA Professional Skill of evaluation.

Ethics is a core part of the Strategic Business Leader syllabus, as such gaining an understanding of the key themes in chapter 9 is particularly important. It is possible that a question requirement in the Strategic Business Leader exam could ask you to identify the ethical threats facing the featured organisation, and to then propose a course of action to address the threats identified. Therefore making sure you are familiar with the typical safeguards that organisations can implement is particularly important. Activities 2 and 3 test the ACCA Professional Skill of scepticism. You should attempt each of these.

Therefore being comfortable with conducting performance evaluations will be of vital importance. Robotics and Artificial Intelligence are changing the way businesses work but lead to ethical considerations as can be seen in Activity 1. The concept of big data has become increasingly important in recent times, as such you are strongly advised to attempt Activity 2 which focuses on the use of big data in relation to strategic development at the featured organisation.

This chapter builds upon the previous chapter and explores the role that e- business has had on organisations. In the Strategic Business Leader exam it is important that you have a good understanding of the ways in which internet- based technologies have impacted on organisations and industries. As we mentioned previously, ultimately you will need to determine whether the use of a particular theoretical model in structuring your answer is appropriate in light of the information presented in the question scenario. Ensuring you are comfortable with the 6 I's model of e-marketing is one of the most important theories in this chapter. Activity 2 which tests the ACCA Professional Skill of commercial acumen provides an opportunity to apply your understanding of the 6 I's model. Activity 3 provides you with an opportunity to attempt providing advice as you are asked to discuss how the featured organisation could develop its website in response to a recent survey. Make sure you take the time to attempt this fully.
