#### **Public Officer's Welcome**

Welcome to the RAVSTASS Annual General Meeting.

### **River** Division

**Director Mark Ferdinands**: A passionate kayaker, Mark has grown his involvement into the new Division Director role. Mark has previously competed in the Murray Marathon and is keen to create more RAVSTASS social Kayaking events. He has already conducted paddling events for work groups and is keen to build on this in 2024.



#### AIR DEVESION

**Director Tim Muehlberg:** Air Division is growing as an active division developing competitive teams. The momentum of 2022 carried over into the 2023 Australian Skydiving Championships, where our 4-way Blast team of Peter McKenzie (Captain & Outside Centre), Sam Glase (Point), Francois Gourichon (Inside Centre), Tim Muehlberg (Tail) and Mark Gazley (Camera); achieved a National Silver Medal. We now have two competitive 4-way Skydiving <u>teams</u>, in training for the NSW/ACT State Championships to be held at Elderslie, NSW over the period 11-12 Nov 2023. Our Ravens A team, while having graduated from the Blast category, have also been busy mentoring our newest Blast team Captained by Paul Schwizler (Outside Centre), Emelia Vassiliou (Point), Brook Ernst (Inside Centre), Andrew Bow (Tail) and Elise Vale (Camera). Meanwhile we have also been advocating with the Australian Parachute Federation (APF) in representing the ideas of our membership for reformatting future competitions. The main thrust of the concept is to schedule grades over different weekends to help grow the sport, through making it possible that the seniors can more effectively mentor the juniors and round out any gaps. Our A team is also trialling the first production batch of RAVSTASS Skydiving suits, which will soon be available online.

We also welcomed <u>Rama Gemo</u> as the first Air Division member in the RAVSTASS <u>Individual Athlete Support Program</u>. Rama is a Drone Pilot and is keen to support your activity with Drone or First Person View (FPV) imagery. Read more <u>here</u>. Looking ahead, we will again be competing in the Military Skydiving Championships to be held this December, where we achieved 4<sup>th</sup> in the A category in 2022. In 2023, we welcome new members Paul Schwizler and Luke Burton to the team. Looking further ahead, our wind tunnel coach Laurence Garceau (LG) has also set the vision for the Ravens to compete in the 2024 Indoor Skydiving Championships. ### Valley Division



### Sea Division



### TRACK DIVISION

**Director Ash Brack**: Our desire for a competitive RAVSTASS team is still being nurtured. We do have a competitive Senior Clubman 125cc Go Kart owned by a benefactor, who is looking for a team of highly motivated and aspirational individuals. Meticulous preparation in not only the kart but the administration and management of a team will be paramount. For these reasons the rush to competition has not been pursued prematurely. Our focus is on building a foundation like Stadium and Air Division established before their achievements. Track Division also welcomed <u>Nick Chivers</u> under the <u>RAVSTASS Individual Athlete</u> <u>Support Program</u>. If you are interested in Remote Control racing, he is more than happy to provide guidance in how to get involved in the sport. Remembering also that Track Division is about beating the clock, and not just motorsport, Blake Muehlberg has been active in competitive long distance running, achieving 2<sup>nd</sup> in his first Conquer the Summit race.



### AIM DIVISION

**Director Ben Trappel**: In previous years, Golf has dominated the mentions. While Adelaide Social Golf has continued to grow and introduce members to the sport, it has been in Ten Pin Bowling that the majority of <u>team achievements</u> have been made. RAVSTASS teams achieved 3<sup>rd</sup> and 1<sup>st</sup> in late 2022 and mid-2023 respectively. Kade Smith also achieved 2<sup>nd</sup> in the 2023 Masters competition in Murray Bridge. As these teams continue into 2024, our SA Masters Games (SAMG) +40 team will be looking to defend their Gold Medal which they have held since 2018. There have been many tight contests over that half decade, and it is a very special group that returns each year, and perhaps for these reasons is found many of our leaders. Our +30 team achieved another solid performance achieving Silver in Kadina last year. As the games return to the same venue, it is worth noting that SA Masters Games is the perfect forum for our Multi-Sport Association to participate beyond Basketball. 

  - 2.3.1 **Internal Audit Report**. Conducted by the Treasurer, noting that the Association's finances are managed on a cash basis accounting method.
  - 2.3.1.1 The Treasurer is satisfied that the *Income Statement* for the period ending 30 Jun fairly presents the results of the associations' activities for the financial year 2022/2023.
  - 2.3.1.2 The Treasurer is satisfied that the *Balance Sheet* as at 30 Jun fairly presents the financial state of the association as at the end of the association's financial year 2022/2023.
  - 2.3.1.3 The Treasurer has reasonable grounds to believe that the association *will be able* to pay its debts as and when they fall due.
  - 2.3.2 External Audit Report. An Independent External Audit was conducted by <u>Barrie Lloyd of LVM Audits Pty Ltd</u>.
