EWEB'S PLAN FOR A CLEAN ENERGY FUTURE

EWEB is developing a plan – called an Integrated Resource Plan – to ensure that Eugene has a sufficient supply of reliable, affordable and clean electricity in the decades ahead.

And we want you to participate in the process!

What is an Integrated Resource Plan (IRP)?

An IRP is a planning document that helps us decide what combination of energy resources EWEB should procure in the next 20 years to meet the needs of our customers. Should we continue to rely on hydropower? Should we build new wind farms? Should we spend money to encourage our customers to conserve electricity?

How much work has been done on the IRP so far?

We've been working on this for about a year, but we still have a lot of work left to do! In December, we released an initial public draft of the IRP. This draft is the summary of our analysis so far. It contains one option for a future portfolio of energy resources that EWEB can pursue. But we know there are other options.

And that's the exciting part. We are continuing our analysis – and we want you to join us. What questions should we explore as we continue our analysis?

What is the climate impact of your electricity?

EWEB's electricity is approximately 90% carbon-free, largely because of low-cost hydropower from dams on the Columbia River. But we need to do better. EWEB has committed to ensuring our electricity is 95% carbon-free by 2030. This requirement is foundational to our IRP.

Key insights from the IRP initial public draft

We have published an initial public draft of the 2022 IRP, and we encourage you to read it. Here's what we learned:



Demand for electricity will grow. We forecast that demand for electricity is going to rise by about 2% per year starting around 2030 as more people switch to electric vehicles and electric heat pumps.



Legacy hydropower is a good fit for EWEB's needs. Hydro is a cheap, carbon-free resource that can generate energy at a moment's notice to meet our customers' demand. Continuing to rely on hydropower is a smart idea.



Wind and batteries offer a possible path forward. One option to meet increased demand is to build new wind farms paired with large, utility-scale batteries. This makes sense because, here in the Northwest, wind is an abundant renewable resource that, unlike solar energy, generally produces power when EWEB has peak needs. And large utility-scale batteries would help smooth gaps in that power generation.



EWEB needs to develop customer programs responsive to energy need. Together we can reduce demand for electricity, especially when demand is at its peak. Electricity used during peaks is generally more expensive for EWEB to provide, and it is also associated with higher carbon emissions.

What is wastewater?

The regional wastewater treatment plant is vital to protecting public health and the environment. The treatment plant removes human waste, chemicals, grease, and other contaminants that are put in our sanitary sewer system. The water goes through a

series of mechanical, biological, and chemical processes before being released into the Willamette River.

Eugene Public Works

Discharging clean, healthy water into the river is essential to communities downstream that rely on the river for drinking water.

All properties connected to the public wastewater system pay wastewater fees. Eugene provides local wastewater collection services, and the Metropolitan Wastewater Management Commission (MWMC), a partnership of Lane County and the cities of Eugene and Springfield, operates the regional wastewater collection and treatment facilities.

Local and regional wastewater fees pay for the collection and conveyance of wastewater through nearly 850 miles of wastewater lines and for the operation and maintenance of wastewater treatment facilities.

- Operate and maintain 31 pump stations (27 local, 4 regional)
- Inspect/clean almost 390 miles of wastewater lines per year
- Treat over 12 billion gallons of wastewater per year
- Conduct more than 28,000 water quality tests
- Process 2,500 dry tons of biosolids per year
- Invest in capital improvements
- Meet water quality regulations to protect the environment

City Fees on EWEB Bill

The City of Eugene adopts and administers the stormwater and wastewater service fees. EWEB acts only as the City's billing agent per City Charter.

What is stormwater?


Stormwater is runoff from hard surfaces in urban areas that must be channeled to prevent flooding, protected or treated to remove contaminants, and finally returned back to our rivers.

Water from your roof or lawn picks up oil from cars, sediment, bacteria, grease, and other chemicals associated with urban life. Instead of going into the ground—nature's filter—those contaminants are carried through our storm pipes and go directly into the Amazon Creek or Willamette River.

To help protect our valuable clean water resources and to meet strict water quality regulations set by the Oregon Department of Environmental Quality, Eugene's City Council adopted a stormwater management plan (SWMP) in 1993 that provides the framework for assessing all properties in Eugene for the cost of managing this system.

Keeping Water Clean

With more than 170,000 people in Eugene, there are a lot of extra contaminants funneled to the river from impervious (non-porous) surfaces. City staff use stormwater fees to help mitigate contaminants of the runoff by providing services such as street sweeping, removing sediment from the storm drain system, and building and maintaining rain gardens. A functioning stormwater system also reduces the risk of flooding.



How stormwater fees are used every year:

- Clean over 8,500 catch basins and curb inlets
- Collect and recycle over 12,000 cubic yards of leaves
- Eliminate illegal discharges and spills into the stormwater system
- Sweep more than 30,000 curb miles of streets
- Provide stormwater education to students in both school districts
- Protect, restore, and maintain streams, rivers, and wetlands
- Plant over 600 trees along local streams and rivers
- Maintain 468 public rain gardens
- Oversee more than 1,500 private rain gardens
- Remove garbage from streams and the banks of the Willamette River
- Improve rainfall runoff management in developed areas
- Replace public drywells to protect groundwater quality
- Administer clean water regulations for construction sites, industries, and new development
- Plant, preserve, and maintain street trees and median vegetation
- Monitor water quality in our local waterways through sampling and data analysis

The average residential customer pays \$17.03 per month, and larger properties pay more.
