1 Overview

The video decoder (referred to as device hereafter) is a new-generation network media terminal designed mainly for remote video surveillance. The device can be used with other devices (such as camera) to capture video images and collect audio from a remote location in real time.

This guide describes the hardware of the device, how to install it, and how to access it on a web browser.

Packing List

Figure 1-1 Front view

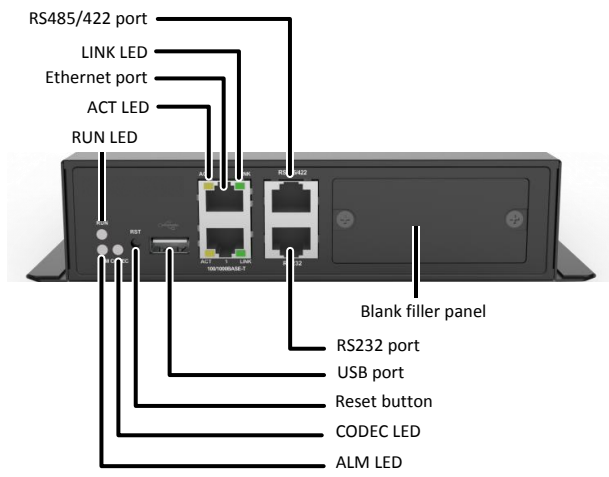
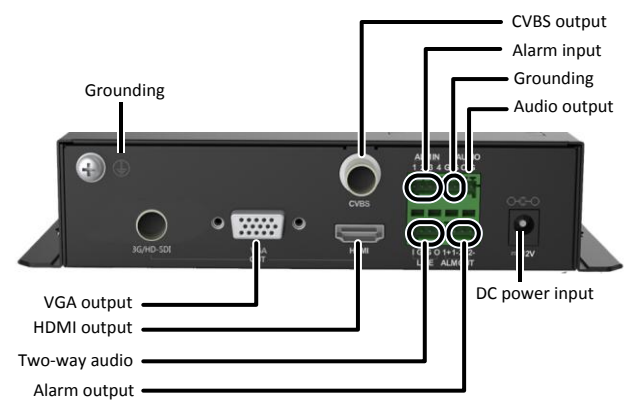


Figure 1-2 Rear view

Table 1-1 LED Descriptions

LED	Description
RUN	Blinks: The device is starting up.

LED	Description
	On: The device is operating.
	Off: The device is shut down.
ALM	On: A device alarm (e.g., temperature alarm) has occurred.
	Off: No device alarm.
CODEC	Blinks: The device is decoding.
	Off: The device is not decoding.
ACT	Blinks: The device is transmitting data.
	Off: The device is not transmitting data.
LINK	On: The device is connected to network.
	Off: The device is not connected to network.

2 Installation

Preparation

Before you start, check against the packing list to ensure all items are complete.



WARNING!

- Do not remove the seal tape on the device chassis. Do not open or disassemble the device. Contact your local dealer if you need assistance. We shall not be responsible for damage caused by unauthorized repair or maintenance.
 - Do not connect power before installation and cable connection are completed.

For indoor use, make sure the following requirements are met:

- Proper lightning protection for power and other ports (audio, video, RS485, etc).
- Proper grounding through the grounding terminal. For details, please refer to the *DVS_DC Cable Connection Guide*.

For outdoor use, check that the above requirements are met, and an outdoor protection box is ready.

Installing the Dual-SFP Module



CAUTION!

- Disconnect power before installing the dual-SFP module.
- Choose a dual-SFP module recommended by your dealer.

Loosen the screws and remove the blank filler panel. Then, insert the dual-SFP module and fasten the screws.



Indoor Installation

Install the device in a rack with a frame or holder. If neither frame nor holder is available, make sure the device is installed securely, and allow sufficient space on both sides for heat dissipation. Do not stack other devices on the device.

The steps are as follows. Refer to the *Video Encoder/Decoder Frame Installation Guide* or the *1U Holder Installation Guide* for details.

1. Install mounting brackets.



2. Install the device in the rack.

Outdoor Installation



NOTE!

Choose a protection box that meets standards. Please refer to the *DVS_DC Cable Connection Guide* for details.

Use screws to secure the device in the protection box, with ventilation openings facing upward and downward. Keep at least 10 cm free space above and below the ventilation openings to ensure effective heat dissipation.

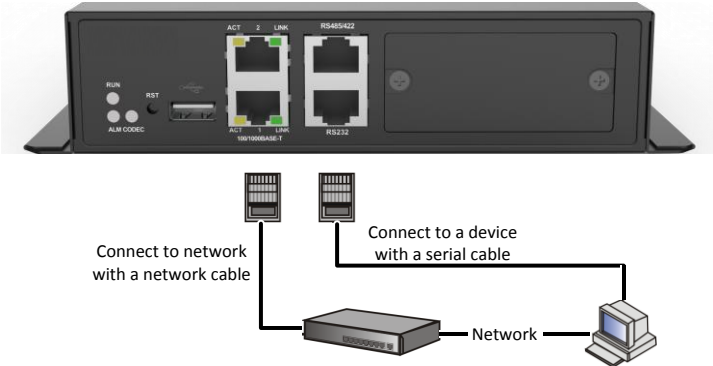
Cable Connection



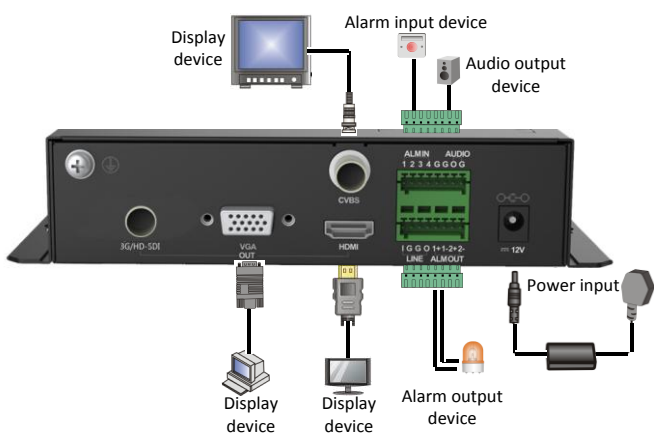

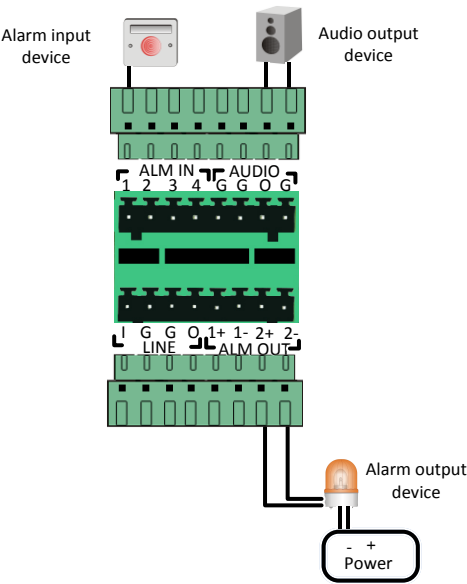
Connecting Cables on the Front Panel

Connecting Audio and Alarm Cables



NOTE!

The alarm output device shall use a DC power supply, and the voltage and current must not exceed 12 V and 0.7 A.

Table 2-1 Phoenix Connector Terminal Description

Terminal	Description
ALM IN: 1–4	Alarm input.
AUDIO: O, G	Audio output. O for audio signal output, and G for grounding.
LINE: 1, G, G, O	Reserved.
ALM OUT: 1+, 1-, 2+, 2-	Alarm output.
G	Grounding.

Verification



WARNING!

Installation and cable connection must be completed properly before the device is connected to power. Otherwise, bodily injury or device damage may occur.

Verify the following before connecting the device to power:

- The device is grounded properly, and all cables are connected correctly.
- The power input voltage is stable.

Starting Up the Device

After you complete the above procedures, connect the device to power.

Check the operation status according to [Table 1-1](#).

3 Login

You can access the device using a Web browser from a computer.

Before you start, check that:

- The device is operating properly.
- The computer is connected to the device on a network.
- The computer is installed with Microsoft Internet Explorer (IE) 7.0 or higher, and no proxy server is being used.



NOTE!

- The default IP address is **192.168.0.14**, the default subnet mask is **255.255.255.0**, and the default gateway address is **192.168.0.1**.
 - Use **admin** as the username and password for your first login. Change the default password on the **User** page to ensure security.

Follow the steps to log in to the device:

1. Open the IE and then enter the IP address of the device in the address bar.
2. On the login page, enter your username and password and then click **Login**.
3. When logged in, manage and configure the device as needed. To log out, click **Exit** in the upper right corner.
