MODEL MVD-70, POCKET NEE

The POCKET NEB handheld vibrating mesh nebulizer is designed for delivery of prescribed medications in aerosol form. The POCKET NEB's compact design allows the unit to be carried with you at all times for aerosol medication delivery. The POCKET NEB utilizes a state of the art vibrating mesh vapor disk incorporated into the medication cup, that when activated creates an aerosol of prescribed medication.

MODEL MVD-70, POCKET NEB

The Model, MVD-70 POCKET NEB electronic vibrating mesh nebulizer is designed to nebulize liquid medications for inhalation by a patient. The POCKET NEB may be used in adults or children 2 years of age and older. THE POCKET NEB is a portable unit for use in and out of the home environment.

The POCKET NEB is not intended as a life sustaining or life-supporting device. The POCKET NEB is not intended for use with Pentamidine.

- Make sure no parts are damaged, the POCKET NEB is assembled properly, and the POCKET NEB operates normally.



- Never attempt to clean medication cup with any foreign object, this could damage the medication cup. Handset will not operate with damaged medication cup. Never touch the mesh vapor disk on the medication cup, damage may occur.
- To prevent damage to the POCKET NEB, remove medication cup from handset and add medication slowly. Do not allow the medication to overflow the medication cup.
- Do not add more than 6 mL of medication to the medication cup.
- Close medication cap before using to prevent leaking of medication.
- Close USB connection port when not in use to prevent moisture damage to the unit.
- Do not operate POCKET NEB if your hands or unit is wet.
- · To prevent damage to the POCKET NEB, make sure that the medication cup is correctly in place. (See illustrations for proper assembly).
- Do not operate the POCKET NEB at temperatures greater than 40°C (104°F) or less than 5°C (41°F).
- · Do not drop the POCKET NEB or any of the components, this could damage unit.
- · If POCKET NEB is dropped, smashed or crushed, damage could occur, POCKET NEB may not operate if the handset or medication cup is damaged. Check POCKET NEB for damage to handset or medication cup if dropped, smashed or crushed.
- · If POCKET NEB has cracks in the handset or medication cup do not use POCKET NEB. Replace damaged parts before attempting to use the POCKET NEB.
- Do not disassemble or attempt to repair the POCKET NEB or components.
- Operate the POCKET NEB only as intended. Do not use the POCKET NEB for any other purpose.





BATTERY CHARGING




- · Charge battery before first use
- · Turn POCKET NEB off before charging
- There are no serviceable parts inside the POCKET NEB handset. Do not attempt to open case. This will damage handset and void warranty.
- Use only approved MicroVapor Devices charging cable and wall plug adapter provided with your POCKET NEB when charging battery.
- The POCKET NEB has a red low battery indicator that will illuminate when the battery level is low. During operation, if the red low battery light comes on, the POCKET NEB should be charged before next use.
- If the low battery indicator red light illuminates for five (5) seconds and then goes off, the battery is completely depleted and must be charged before it can be used again. NOTE: The unit will not operate if the battery is completely depleted.

- Charge battery only when red low battery light illuminates to assure maximum battery life and proper operation of your POCKET NEB.
- Always charge the handset in a dry area.
- Charge battery according to instructions to assure maximum battery life.
- The POCKET NEB operates using a rechargeable lithium ion battery. Follow charging instructions to assure that your POCKET NEB is in operating condition. The POCKET NEB battery life is 350 charge/ discharge cycles. To assure maximum battery life only charge the POCKET NEB when low battery indicator light comes on.
- Do not use POCKET NEB when charging the battery.

CHARGING BATTERY:

1. Turn POCKET NEB off. Plug wall AC adapter into wall power outlet. Plug Micro USB charger cable into the handset as shown in the illustration.



- 2. Red low battery indicator light will blink to show battery is charging.
- 3. Green LED will blink slowly when battery is fully charged. NOTE: Charging time will vary depending on condition of battery. Using the supplied AC adapter a full charge will take 4 to 6 hours if battery is completely discharged.
- 4. Remove USB charger cable before operating your POCKET NEB.
- 5. Place USB charger cable and plug in the carrying bag and store in a dry area. NOTE: DO NOT USE POCKET NEB WHEN CONNECTED TO CHARGER




- Clean medication cup and mesh vapor disk before using the POCKET NEB for the first time after purchase. (See cleaning instructions).
- · If the POCKET NEB has not been used for a long period of time, clean medication cup and mesh vapor disk before using (see cleaning instructions).

Components will fit tightly since they are made to prevent the medication from leaking.

- 1. Hold the POCKET NEB securely.
- 2. Make sure all parts are assembled securely for proper operation of POCKET NEB.
- 3. Attach the medication cup to the handset by sliding the medication cup onto the top of the handset.



4. Attach the mouthpiece or mask adapter to the medication cup. Mouthpiece/mask adapter connects to mesh vapor disk by pushing mouthpiece/mask adapter on to the mesh vapor disk. Mouthpiece and mask adapter should fit tightly to the medication cup. If using a mask be sure to place mask on the mask adapter before use.








Press On/Off button to start nebulization. Green power light will illuminate. NOTE: If On/ Off green LED and low battery red LED are blinking, the medication cup is not attached



CLEANING THE POCKET NEB

Follow the cleaning instructions at the end of each day of use to prevent any remaining medication in the medication cup from drying or adhering to the mesh vapor disk. Failure to follow these instructions will result in a clogged mesh vapor disk and ineffective nebulization from the POCKET NEB.

Clean the entire medication cup, mesh vapor disk, mask, mouthpiece or mask adapter after each day of use. Failure to clean medication cup and mesh vapor disk may cause the POCKET NEB not to operate properly.

Medication cup must be changed after 45 days of use. Failure to change medication cup could cause POCKET NEB not to operate properly.





- To clean handset, wipe handset with cloth dampened with distilled water. NOTE: Never place handset under running water. Never clean handset with alcohol, abrasive or any chemical cleaners.
- Air dry medication cup and replace on handset. NOTE: The POCKET NEB comes with a mesh vapor disk cap to protect the mesh vapor disk when not in use. Place mesh vapor disk cap over the nozzle opening for the mesh vapor disk when POCKET NEB is not in use.
