Terms and Conditions

7-DAY COOLING OFF PERIOD

Diamond Valley Kennels Pty Ltd (“DVK”) offers its customers buying a puppy from DVK, a 7-day cooling off period commencing from the date the customer receives the puppy from DVK.

The Terms and Conditions of our cooling off period are as follows:

- Provided you return the puppy within the first 3-days of purchase, DVK will refund you 70% of the purchase price paid.
- Provided you return the puppy within 4 to 7-days of purchase, DVK will refund you 50% of the purchase price paid.

DVK has implemented these 7-day Cooling Off Period Terms and Conditions to ensure the best outcome for the pet, you as our valued customer and in covering DVK`s costs both internally and externally (i.e. Vet checks; 2-week quarantine period and re-advertising costs etc.).

The Puppy that you have purchased from Diamond Valley Kennels Pty Ltd has been checked by my vet and has been determined to be in good health. My vet has determined that your new Puppy's heart is healthy, and that puppy is free of any hernias; unless otherwise declared by DVK at time of purchase and a reduced price has been agreed upon by both parties to accept this condition.

1. Your new Puppy has received their first vaccination by my vet. You must arrange follow up visits to your vet for the Puppy's second and third vaccinations at your own expense.
2. You have 72 hours to take your puppy that you purchased from Diamond Valley Kennels Pty Ltd to the vet of your choice to have a puppy health check-up completed at your own expense.
3. The puppy is sold as a family pet not for show quality.
4. The puppy is sold on the understanding that it is to be treated with humane care for its entire life. I, as the puppy's new owner, am responsible for its veterinary expenses and any other expenses it may occur during the puppy's life time.
5. Diamond Valley Kennels Pty Ltd will, in no way, be responsible for any Local Government Council Dog Registration Fee. It is the responsibility of the new owner (name as stated above) to register the dog with your local Council as per local regulations.
6. Your new puppy is sold on the condition that the purchaser will abide to this Agreement.
 - a. This health guarantee does not apply if your puppy goes down with hypoglycaemia (fluctuations in blood sugar which can occur in small breed puppies), coccidia, giardia or any condition that can be corrected by surgery or treated with medication.
 - b. If the 2nd and 3rd vaccinations are not completed, this health guarantee is void.
 - c. If you expose your puppy to outside environments that can make your puppy sick, ie taking to the park, exposure to other animals prior to the full vaccinations being completed, this health guarantee is void.
7. It is your responsibility to make sure the puppy always has food and water. You must make sure puppy is eating and drinking. Puppy must be kept indoors not outdoors. Puppy needs to eat, sleep and play.
8. If you have chosen to fly your puppy to a destination within Australia and wish to return Puppy under our 7-day cooling off period; it is your responsibility and at your own expense to return Puppy in perfect health to Diamond Valley Kennels Pty Ltd at Diamond Valley Qld. The puppy must be returned within the 7-day period and can only be returned if prior agreement has been accepted by Lisa Howlett, Director Diamond Valley Kennels Pty Ltd.

It is your responsibility as the new owner of puppy from the moment you purchase your new puppy to take good care of puppy as stated above.
