Segregation

Customers manufacturing or repacking these products should consider their own labelling requirements based on the information given for each product and this allergen policy statement. Additional trace labelling information is the customers' responsibility, JustIngredients Ltd will work with customers to give additional information, where requested, to allow customers' to carry out a risk assessment on individual products.
