# **Emergency Overview**

Physical Description & Colour: Dark pink opaque viscous cream presented as an aerosol.

### **Potential Health Effects**

### Inhalation:

**Short Term Exposure:** Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort. Intentional misuse by deliberately concentrating and inhaling contents of aerosol containers can be harmful or fatal.

**Long Term Exposure:** No data for health effects associated with long term inhalation.

## **Skin Contact:**

**Short Term Exposure:** Major health effect from this product is misuse of the aerosol function. If sprayed continuously on skin or in eyes, it can cause frostbite.

# Section 4 - first aid measures

### **General Information:**

# Section 5 - fire fighting measures

**Fire and Explosion Hazards**: The major hazard in fires is usually inhalation of heated and toxic or oxygen deficient (or both), fire gases. There is a moderate risk of an explosion from this product if commercial quantities are involved in a fire. Firefighters should take care and appropriate precautions. Vapours from this product are heavier than air and may accumulate in sumps, pits and other low-lying spaces, forming potentially explosive mixtures. They may also flash back considerable distances.

## Section 6 - accidental release measures

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern. For minor spills, clean up, rinsing to sewer and put empty container in garbage. Although no special protective clothing is normally necessary because of occasional minor contact with this product, it is good practice to wear impermeable gloves when handling chemical products.
