Any secondary stores, pop-up shops, website sales, online sales, or any other sales outlets are not included in this agreement and must receive specific written approval to sell Be The Light Malas products.

## Payment Information and Terms

Be The Light Malas accepts credit card, PayPal payments online via our website or via electronic invoices such as Brandboom with payment terms net30. Retailers may also apply for credit terms with us by filling out an application form with at least three credit references. Credit application forms can be requested via email.

No initial orders are processed or shipped until the initial payment is received in full or credit terms have been approved.

Initial orders, orders on special offers, or specified sale orders may have different terms for their respective orders and are to be considered one-time events. All other orders, unless specified in writing otherwise, are to follow the terms outlined in this agreement.

Please note Be The Light Malas may hold limited stock in certain styles or lines, and orders placed without immediate payment cannot be guaranteed stock for orders intended to be processed in the future. If a style or line is not available at your time of purchase, Be The Light Malas will not charge you for item(s) and will not hold the item(s) against minimum order or minimum quantity requirements.

We reserve the right to alter our prices at any time unless prior invoiced.

### Shipping and Handling

The retailer incurs the shipping costs. We use USPS, FedEx, and UPS. If you are unable to receive shipments from any of the aforementioned carriers, you must notify us upon placing an order. Any additional shipping costs resulting from shipments that are undeliverable and are returned to us will be billed back to you at cost. If your shipment is damaged in transit, you agree to contact Be The Light Malas within 5 days of delivery.
