In placing your order, it will be assumed that you have read and accept the conditions set out below.

We reserve the right to change these Terms & Conditions without prior notice. Nothing stated or implied on this page will affect your statutory rights

#### MAKING A PURCHASE

Purchase using our secure website or complete the order form overleaf, using block capitals, providing your preferred method of payment and post to:

You must provide us with accurate information, be at least 18 years of age and be legally able to enter into a contract for Goods and services. Once we have received your order, we will issue Confirmation of Order either by post or email. It is the customer's responsibility to check any email filters that may interfere with our communication to you. We strongly recommend that you retain a copy of your Confirmation of Order for your records. Our acceptance of your offer to purchase Goods is subject to their availability.

#### METHOD OF PAYMENT by post

We require that full payment be made and that it is cleared in our bank account prior to dispatch. It is entirely at our discretion to accept or reject the offer to purchase.

We accept cheques or postal orders(drawn on a major UK Bank) made payable to CHARLFRED FINE ART, with an order form through the post; or you can provide your credit/debit card details on the order form and return by email or post. We accept the following Credit/Debit Cards: Mastercard, Maestro, Visa, Solo, Electron and American Express. Your credit/debit card will be charged shortly after you submit your order.

#### SECURITY

The personal details you submit on our Website are totally encrypted using SSL (Sucure socket Layer) software. Charlfred Fine Art has a strict policy not to sell or transfer any personal customer details, including email and postal addresses to third parties. The only exception is details required by our Payment Service Provider to process your card transactions.

#### PRICES

Prices are quoted in Pounds Sterling (GBP £). Charifred Fine Art accepts payment in Pounds Sterling only. Prices are subject to change. We reserve the right not to send an item if we make a pricing error. We reserve our right to sometimes sell the same items at a higher or lower price elsewhere.

#### VAT

Prices include Value Added Tax (VAT) at the current rate of 20%. Charlfred Fine Art is VAT Registered under No. 929 6623 85. VAT is not charged on orders from outside the EU. If you would like an itemised VAT receipt, please contact us and we will be happy to post this to you.

#### **GOVERNING LAW**

Occasionally, there may be a variation to mounts and/or frame moulding depicted in the catalogue or on the website, but be assured that the quality and aesthetics are always our priority.

#### **DELIVERY**

Please allow 14 working days for delivery to a UK Mainland address and 28 working days for all other areas, including overseas. Working days are Monday – Friday, not including Saturdays, Sundays and Bank or Public Holidays. Delivery timescales are given as an approximate guide. We cannot be held responsible for delays in delivery beyond our control. We are not liable if orders are lost in the post. Goods shall be at the Buyers risk from delivery. You can specify for your order to be sent to another address, providing a signature can be obtained on delivery. Receipt of a signature at the delivery address will be proof that the order has been delivered.

Unmounted prints are carefully flat-packed, mounted and framed prints are packaged into heavy-duty cardboard boxes. Postage and packing is included in the price when being sent to a UK Mainland address.

We are happy to send mounted prints Worldwide, however due to insurance reasons it is not possible for us to despatch framed prints or original paintings outside the UK Mainland. Delivery charges are non-refundable, except when returning goods that are faulty or damaged.

# CUSTOMS & IMPORT DUTIES

The customer is responsible for the payment of surcharges. Any Customs or Import Duties are levied once the package reaches your country. Additional charges for Customs clearance must be borne by the customer as we have no control over charges and cannot predict what they might be. Since Customs policies vary throughout the world, you may want to contact your local Customs Office for further information before placing

# GIFT WRAPPING SERVICE

This service is available to UK Mainland customers only. Charges apply and are subject to change. Gift wrapping service includes: mounted or framed print wrapped in gift wrapping paper with a supplied blank gift tag, decorated with ribbon & bow. Gift tag can be personalized by providing us with your message (complete appropriate section of the order form) and we will include this message on the gift tag. Occasionally, there may be a variation to wrapping paper, ribbon and/or gift tag but be assured that quality is always our priority. Gift-wrapped orders can be sent to another address, providing it is a UK Mainland address and a signature can be obtained on delivery.

# CANCELLATIONS & REFUNDS

If your order cannot be fulfilled you will be offered an alternative or given a full refund. Should you wish to withdraw your offer to purchase from us prior to despatch, you must notify us of this fact in writing and we will offer you an alternative or give a full refund. We recommend you keep all original packaging for a few days after receiving a delivery just in case you need to return Goods.

In the unlikely event that you are not completely satisfied with your new purchase, please contact us within 72 hours. You may carefully return goods in their original condition and packaging within 7 working days of delivery for a refund. In the unlikely event that the Goods received are faulty, incorrect or damaged in transit, please contact us within 72 hours, stating the nature of the defect to packaging and/or contents. We would ask you to send the Goods back to us within 7 working days, securely wrapped incorporating the original packaging and we will reimburse you the cost of the postage - postal receipt must be supplied.

If we agree that the Goods returned to us are indeed defective, we shall, at your option: (i) deliver replacement Goods of similar quality and specification, no delivery charge (ii) arrange for a full refund, providing that the Goods were faulty, incorrect or damaged in transit when sent to you, and have not been subsequently modified or subject to misuse or negligence. A refund of any monies paid will be made only for goods that are returned to us. All returns must be in 100% resaleable condition.
