THIS LIMITED WARRANTY ("**Limited Warranty**") applies to new Cubicon hardware devices (Cubicon Single+ 3D printer, Cubicon Style 3D printer, the Single+ Extruder, the Style extruder, the Single+ build plate, the Style build plate) (collectively the "**Products**") sold by InkSmith Limited, headquartered at 640 Bridge St W. Waterloo Ontario ("**InkSmith**").

(A) LIMITED WARRANTY

InkSmith represents and warrants to the first end-user ("End-User") of Products that the Products shall materially conform to Cubicon's published specifications in the user manual, subject to the terms and conditions of this Limited Warranty.

Consumable parts not covered by the Limited are: filament, SD card and USB keys. "Consumables" are defined herein as disposable items, parts or components of the Product which are inherently subject to deterioration and wear out during the normal operation of the Product.

(B) FOR A WARRANTY CLAIM TO BE VALID

The validity and enforceability of the Warranty is conditional upon the following:

- i. End-User must notify InkSmith of a defect of the Product before the end of the applicable Warranty Period, as such Warranty Periods are defined below;
- ii. End-User must provide InkSmith, upon request, End-User logs and/or any other documentation, acting reasonably; and
- iii. End-User must provide an original proof of purchase from InkSmith or an authorized distributor of InkSmith (the "**Authorized Party**"), including the serial number of the Product(s).

(C) WARRANTY PERIOD

The "Warranty Period" commences on the date of receipt of the Product by the End-User ("**Delivery Date**") to the first anniversary of the Delivery Date

(D) CLAIM HANDLING

In the event that the Products do not conform to the representation and warranty referred to in Section A herein, the End-User may make a claim (the "Claim") by providing notice pursuant to Section F during the Warranty Period. Provided that the exclusions referred to in Section E is not applicable to the subject matter of the Claim, such Claim made by End-User pursuant to this Limited Warranty shall be administered as follows:

- i. Cubicon or its authorized representatives shall determine, in its sole discretion whether InkSmith or its authorized representatives shall remedy the defect by repair or replacement of the non-conforming hardware Product or nonconforming part(s) of a hardware Product.
- ii. InkSmith shall bear the cost of repair and/or replacement and the shipping costs incurred therein, provided, however, that the return is authorized via an RMA number issued by InkSmith and End-User complies with the return instructions;



- iii. replacement parts or Products provided by InkSmith will either be new or refurbished and will be furnished on an exchange basis. If defective parts or Products are not returned by End-User, InkSmith shall bill the End-User for the unreturned hardware; and
- iv. All replaced parts and Products returned to InkSmith from the End-User shall become the property of InkSmith.

(E) EXCLUSIONS

The obligations of InkSmith under this Limited Warranty do not cover physical damage sustained from improper handling by shippers during shipping as well as normal wear and tear in use of Product.

In addition, this Limited Warranty shall be voided if alleged Product failure was caused in whole or part by

- i. improperly or incorrectly performed modification, alteration or repair by anyone who is not certified or approved by InkSmith or its designated representative;
- ii. installation of part or Consumable by anyone not certified or approved by InkSmith or its designated representative, including without limitation the use of filament not from InkSmith;
- iii. physical or electrical stress;
- iv. abuse, misuse, accident, neglect, not the fault of InkSmith;
- v. exposure to moisture, flooding, fire, electrical problems associated with incoming power or other acts not the fault of InkSmith;
- vi. not adhering to InkSmith's recommended maintenance procedures or failure to comply with Product instructions and/or documentation; or
- vii. to the extent allowed by applicable law, removal of the Product from the country or region where it was originally sold by InkSmith or its designated representative.

InkSmith shall make the final determination as to the existence and cause of any alleged defect.
