

# Yellow Design Studio Application License

By downloading, installing and/or embedding font software ("Font") offered by Yellow Design Studio you ("Licensee") agree to be bound by the following terms and conditions of this End User Licensing Agreement ("EULA"):

# 1. Right Granted

Yellow Design Studio grants Licensee a perpetual, worldwide, non-exclusive and non-transferrable license to:

a. Embed the licensed Font into an unlimited number of copies and subsequent versions of the Application(s) ["App" or "Apps"].

b. Modify or convert the Font to improve the Font's appearance or performance in the App.

## 2. Requirements and Restrictions

Licensee agrees to abide by the following requirements and restrictions:

- a. Licensee may embed the Font into ONLY the number of Apps specified at the time of purchase.
- b. Licensee may not redistribute the Font with the App's source code.
- c. Licensee may not install the Font in the operating system the App runs on.
- d. Licensee may not embed the Font in any application software considered to be a plug-in, template, skin or theme.
- e. Licensee may not embed the Font in an App that enables an end user to create custom typesetting with the Font.
- f. Licensee may embed the Font in reports that the App saves or exports, provided that the reports are not sold for profit.

## 3. Provision to Third Parties

Licensee may temporarily provide the Font to a producer, publisher or other agent who is working on behalf of the Licensee, only if the producer, publisher,

or other agent (1) agrees in writing to use the Font exclusively for Licensee's work, according to the terms of this EULA, and (2) retains no copies of the Font upon completion of the work.

Licensee may not otherwise distribute the Font to third parties or make the Font publicly accessible or available except by embedding or linking in accordance with this EULA.

## 4. Term

This EULA grants a perpetual license for the rights set forth in Paragraph 1 unless and until the EULA terminates under Paragraph 8. Yellow Design Studio will not charge additional fees post purchase, annually or otherwise.

## 5. Other Usage

Licenses for desktop use, @font-face embedding, Ebooks and Epubs, product creation websites, website template distribution, website templates, and other uses not allowed by this Agreement may be available for an additional fee. ### 6. Modifications

Licensee may not modify the Font or create derivative works based upon the Font without prior written consent from Yellow Design Studio EXCEPT THAT Licensee may generate files necessary for embedding or linking in accordance with this EULA.

# 7. Copyright

The Font is protected by copyright law. Yellow Design Studio is the sole, exclusive owner of all intellectual property rights, including rights under copyright and trademark law. Licensee agrees not to use the Font in any manner that infringes the intellectual property rights of Yellow Design Studio or violates the terms of this EULA. Licensee will be held legally responsible, and indemnifies Yellow Design Studio, for any infringements on the foundry's rights caused by failure to abide by the terms of this EULA.

## 8. Termination

This EULA is effective until terminated. If Licensee fails to comply with any term of this EULA, Yellow Design Studio may terminate the EULA with 30 days notice. This EULA will terminate automatically 30 days after the issuance of such notice.

# 9. Disclaimer and Limited Warranty

Yellow Design Studio warrants the Product to be free from defects in materials and workmanship under normal use for a period of twenty one (21) days from the date of delivery as shown on Receipt. Yellow Design Studio's entire liability, and Licensee's exclusive remedy, for a defective product shall be, at Yellow Design Studio's election, either [1] return of purchase price or [2] replacement of any such product that is returned to Yellow Design Studio with a copy of the Receipt. Yellow Design Studio shall have no responsibility to replace the product or refund the purchase price if failure results from accident, abuse or misapplication, or if any product is lost or damaged due to theft, fire, or negligence. Any replacement product will be warranted for twenty one [21] days. This warranty gives Licensee specific legal rights. Licensee may have other rights, which vary from state to state.

EXCEPT AS EXPRESSLY PROVIDED ABOVE, THE PRODUCT, IS PROVIDED "AS IS". YELLOW DESIGN STUDIO MAKES NO WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

The entire risk as to the quality and performance of the Product rests upon Licensee. Yellow Design Studio does not warrant that the functions contained in the Product will meet Licensee's requirements or that the operation of the software will be uninterrupted or error free.

YELLOW DESIGN STUDIO SHALL NOT BE LIABLE FOR ANY DIRECT, INDIRECT, CONSEQUENTIAL, OR INCIDENTAL DAMAGES (INCLUDING DAMAGES FROM LOSS OF BUSINESS PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, AND THE LIKE) ARISING OUT OF THE USE OF OR INABILITY TO USE THE PRODUCT EVEN IF YELLOW DESIGN STUDIO OR THE FOUNDRY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

Because some states do not allow the exclusion or limitation of liability for consequential or incidental

damages, the above limitation may not apply to Licensee.

# 10. Governing Law

This EULA is governed by the laws of the United States of America and the State of Florida.

# 11. Entire Agreement

This EULA, in conjunction with the receipt ("Receipt") that accompanies each Font licensed from Yellow Design Studio constitutes the entire agreement between Yellow Design Studio and Licensee.

## 12. Modification

The Parties may modify or amend this EULA in writing.

#### 13. Waiver.

The waiver of one breach or default hereunder shall not constitute the waiver of any subsequent breach or default.
