




PRODUCT INSTRUCTIONS

· To Use Max Repel S

 Remove one or two FLEXTAIL Max Repel S Mat(s) from Wrapper. Insert the mat(s) under the Black Grill(s).





Double press the switch to activate the Max Repel S.
 It can takes up to 10 minutes for the Zone to fully established.





3. When finish using the Max Repel S, double press the switch to turn it off and let it cool completely.



· To Switch Mode

After activated, the initial mode is camping mode.

CAMPING MODE (LOW MODE)

The mode indicator light turns green under camping mode.





OUTDOOR MODE(HIGH MODE)


Press the switch once and the mode indicator light turns red.


· Charge Your Device
