

USE INFORMATION

Always thoroughly vacuum the carpet and remove any attached deposits from the carpet prior to use. If there is a question on the carpet's colorfastness, always pretest in an inconspicuous area.



EXTRACTION

- 1. **MIX** at 1 ounce per gallon (1:128 ratio) of hot water. Use at 2 ounces per gallon (1:64 ratio) on heavily soiled carpets. *For best results on traffic lanes, prespray with Answer™ Multi-Use Carpet Cleaner following label directions.*
- 2. EXTRACT.
- 3. FORCE DRY the carpet with fans or carpet dryers.

WARNING

Prevention

Response

If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Specific treatment (see SDS). If skin irritation occurs: Get medical advice / attention. If eye irritation persists: Get medical advice / attention. Take off contaminated clothing and wash before reuse.
