

The equestrian petite Da Brim[®] helmet visor product is designed to be installed to an equestrian helmet to be used with equestrian sporting activities <u>only</u>. The equestrian petite model Da Brim is not designed for and should not be used with motorized sports and/or helmets and classes 5 and 6 whitewater helmets, bicycle helmets, or while engaged in any activity other than equestrian sports while wearing an equestrian helmet. We offer other model Da Brims that may be appropriate for other sports; see our website at www.DaBrim.com for more details. Do not use the Da Brim visor other than as instructed herein and do not modify the Da Brim product. Read and understand all instructions and warnings prior to use.

Equestrian Petite Da Brim® helmet visor installation is quick and easy!

The equestrian petite model Da Brim may be used with either 1. equestrian helmets that have a visor over 1" that is pre-molded into the helmet that cannot be removed or 2. an equestrian helmet that has a removable visor or non-removable small lip up to 1". First, determine what style helmet you have. If your helmet has a non-removable, small lip up to 1" in width or came with a visor that is removable, you should remove the visor and proceed to instructions for this type of helmet in Section 2 for proper fit.

<u>Section 1.</u> If your helmet has a non-removable visor greater than 1" in width, you should install the Da Brim visor using the pocket feature of the equestrian petite model. The following instructions will show you how to correctly install your Da Brim visor to your helmet. When using the equestrian petite Da Brim visor, make sure the fasteners in the pocket are sealed and that the pocket does not obstruct your vision after installation. Obstruction of your vision can cause a crash and may lead to serious bodily injury or even death.

Step 1. Begin with a loose adjustment strap.

Step 2. Open the front pocket by separating the hook and loop fasteners. Insert the helmet's non-detachable visor into the pocket. Do not close the pocket fasteners yet.



Step 3. Pull the rear of the Da Brim visor down and seat the brim on the helmet. Make sure the crown of the brim is level around the helmet's circumference and does not interfere with where your ears will sit.



Step 4. Make sure the visor is as far inside the pocket as possible when the front of the equestrian petite Da Brim is resting flat against the front of the helmet. Tighten the strap by positioning your thumb at the rear of the helmet and pulling on the strap a few times. Tuck the strap into the hole provided.



Step 5. Close the fasteners on the front pocket by mating the hook and loops. Make sure the pocket is tightly closed. The brim should not be buckled or bowed. Double check the tightness of the strap.

Step 6. Check for correct installation. Centers of helmet and equestrian petite Da Brim® visor should align. Always ensure the strap is tight. The brim should always seat in a level plane around the helmet with the front pocket tightly closed, to prevent detachment. Inspect hook and look fasteners regularly for wear. If the fasteners do not function properly, discontinue use of this product. Check by pulling upward on the front of the visor as if in wind flow—the Da Brim visor should not be loose or detach from the helmet. If the brim does not seat as described herein, do not use the Da Brim® helmet visor with this helmet. Failure to properly seat the Da Brim visor could result in the Da Brim visor unseating during use and startling you or others, startling a horse, or obstructing your vision, which may lead to serious injury or even death.

Step 7. After the brim is installed on the helmet, follow the helmet manufacturer's instructions for fitting the helmet. Then, while the helmet and Da Brim product are fitted, and prior to using the helmet and Da Brim product in an activity, check to ensure that the Da Brim visor does not obstruct your vision. Pay attention to your peripheral vision. Should your vision be obstructed by the Da Brim product, remove the helmet and reinstall the Da Brim product. After proper installation of the Da Brim visor to the helmet, your vision should not be obstructed.

To remove the Da Brim visor from the helmet, wait until you are at safe location and at a rest position, then disengage the Da Brim visor by releasing the tension on the strap by pulling up on the buckle. Pull up on the rear of the Da Brim visor and remove.

<u>Section 2.</u> The following instructions apply when you want to use your equestrian petite Da Brim visor with an equestrian helmet that has a flush front, removable visor, or pre-molded lip up to 1" in width. When using the equestrian petite Da Brim visor, make sure the fasteners in the pocket are sealed and that the pocket does not obstruct your vision after installation. Obstruction of your vision can cause a crash and may lead to serious bodily injury or even death.

Installation is quick and easy!


If your helmet has a removable visor, you should remove the visor before installing the Da Brim product.

Step 1. Begin with a loose adjustment strap.


Step 2. Hold your helmet at the center back with your thumb on the outside and grip the center back loop of the Da Brim visor at the same place with your thumb.



Step 3. Place your other hand at the front of the brim and rotate the assembly upside down. Push the helmet against your chest and slowly pull the Da Brim visor over the helmet, seating the Da Brim visor's edge on the helmet. The black underside of the brim should end at the bottom edge of the helmet.



Step 4. Flip the assembly over and tighten the strap by positioning your thumb at the rear of the helmet and pulling on the strap. Tuck the strap into the hole provided.



Step 5. Check for correct installation. Centers of helmet and Da Brim visor should align; if necessary, pull to straighten. Always ensure the strap is tight. The equestrian petite Da Brim® visor should always seat below the front helmet surface, as shown, to prevent detachment. The front pocket should be closed and have a low profile. Inspect hook and loop fasteners regularly for wear. If the fasteners do not function properly, discontinue use of this product. Check by pulling upward on the front of the visor as if in wind flow—the Da Brim visor should not be loose or detach from the helmet. If the Da Brim product does not seat as described herein, do not use the Da Brim product with this helmet. Failure to properly seat the Da Brim product could result in the Da Brim product unseating during use and startling you or others, startling a horse, or obstructing your vision, which may lead to serious injury or even death.



Step 6. After the Da Brim visor is installed on the helmet, follow the helmet manufacturer's instructions for fitting the helmet. Then, while the helmet and Da Brim visor are fitted, and prior to using the helmet and Da Brim visor in an activity, check to ensure that the Da Brim visor does not obstruct your vision. You are responsible for your own safety. The Da Brim visor is not a substitute for a helmet and does not provide impact protection. Follow this product's instructions for proper use—failure to do so could result in serious bodily injury or death. Always follow the helmet manufacturer's warnings and instructions; if a conflict between this product's and the helmet's instructions exist, follow the helmet's instructions.

<u>WARNING!</u> Adult Supervision Required. The Da Brim visor is not a toy. If not properly fitted and installed, the Da Brim visor may obstruct vision, which may lead to serious bodily injury or death depending on the activity. Additionally, the Da Brim visor straps may become entangled during certain activities such as swimming, climbing, or playing on playground equipment, which may lead to strangulation. Adult supervision is required to ensure the Da Brim visor is installed correctly and used as intended.

<u>WARNING!</u> The Da Brim visor may affect the ability of the helmet to slide during a crash. The Da Brim visor may compromise the helmet's ability to slide during a crash. Failure of a helmet to slide during a crash may lead to serious neck or bodily injury, or even death. Do not use the Da Brim visor unless you are willing to assume all risks associated with use of the Da Brim visor.

<u>WARNING!</u> The life of the Da Brim visor may be less than 5 years. The life of the Da Brim visor may be affected by heavy use, exposure to the environment, and other factors. The ability of the Da Brim visor to be properly secured to the helmet may be compromised once visible wear or damage to the body, brim, straps, buckles, or fasteners exists. At such time, the Da Brim visor should be discarded or replaced. Without the ability to be properly secured to the helmet as described in the installation instructions, the Da Brim visor may not stay in position and obstruct vision while involved in activity. Obstructing vision while involved in the sport may lead to a crash, resulting in serious bodily injury, or even death.

<u>Care</u>. Hand wash separately in cold water. Do not bleach. Hang to dry. Do not wring. Do not iron. Store flat. Do not expose to high heat environments, such as the interior of a car on a hot day. Do not fold over 180 degrees or kink the outer support rod—the product may become damaged and its integrity may be compromised.
