# DELAWARE RED PITBULLS

IN ACCORDANCE WITH CONTRACT AGREEMENT THE FOLLOWING APPLY:

- Puppies are required to be paid for in full prior to 7 weeks of age.
- Deposits are absolutely NON-refundable but can be transferred to another litter with written notice prior to 6 weeks of age. Any over payments more than agreed deposit amounts are refundable. If puppy is paid in full prior to requesting refund, deposit will not be refunded but deposit is always transferable. Balance thereafter deposit will be refunded. Overall, full commitment is required at time of signing contract/purchase. No exceptions.
- **DRP** is not partners with our recommended carrier service and are not liable for their services. We encourage you to research our referral. Although we recommend our provider and organize shipping services, it is your choice how your pet is transported. **DRP**'s personal delivery service is fully guaranteed by us and is our most assuring offered shipping service.
- Both parties agree that no Dogs / Puppies, nor Sire or Dam of such have been bred or sold for fighting or any illegal purposes.
- Buyer agrees to have pup examined by Licensed Veterinarian within 72 hours of transfer. If at this time pup is found to have any of the above-mentioned health problems, **DRP** will replace puppy provided the condition is sufficiently serious in the opinion of 2 qualified Veterinarians, at least one of which the breeder agrees to, to warrant Euthanasia.
- **DRP** is not liable or responsible for your canine behavior after puppy / dog transfers ownership/possession from **DRP** to new owner. Although we are always available for consultation and for training referrals if obedience training is desired or needed. Overall, genetics and or breed type will not be held responsible for any negative behavior. By signing this contract, buyer agrees to raise their **DRP** with the upmost love and respect. If bad behavior or habits shall arise at any life stage, buyer agrees to seek professional canine training before seeking adoption or rehoming. **DRP** is willing to consult with trainer.
- By signing you agree to keep **DRP** updated with your puppy throughout his/her life. If you follow us, you know this is important. We require occasional pictures via email/social media. Our relationship is mutual. We will always be here for you throughout your dog's life, please be there for us with occasional updates a few times a year.
- Pup will have U.K.C. registration papers / current on vaccinations, registry information, events, dog shows, etc.
