

“GAMING PACKAGE” CONTEST RULES (the “Rules”)

Under the “GAMING PACKAGE” Contest (the “Contest”) organized by George Richards (“Organizer”) doing business as Grafton Apparel (“Grafton Apparel”) and taking place between Monday, February 28 2028 at 12:01 am EST and Sunday, May 1, 2022 at 11:59 p.m. EST, the undersigned (the “Winner”) will be chosen at random in a draw that will be held no later than Monday, May 16th, 2022.

1. ELIGIBILITY

The Contest is open to all residents of Canada who have reached the age of majority in their province or territory of residence by the Contest Opening Date, except for employees, agents and representatives of the Organizer, its subsidiaries, affiliates, affiliated companies, advertising or promotion agencies, the suppliers of material, prizes and services related to this Contest, and any other stakeholder directly related to the holding of the Contest, as well as the members of their immediate family (father, mother, brothers, sisters, children and legal or de facto spouse) and anyone with whom these employees, representatives and agents reside.

2. HOW TO ENTER

2.1. No purchase necessary

2.1.1. To enter the Contest, the contestant (the “Contestant”) must fill out the form on contest application available at www.georgerichards.ca/cash and provide the following mandatory information: (i) first name; (ii) last name; (iii) email address; (iv) phone number; (v) address; (vi) date of birth to confirm that he/she has reached the age of majority in his/her province; (vii) that they have read and understood the contest rules and (viii) agrees to receive marketing emails from Tip Top, before the Contest Closing Date, to be automatically entered.

2.1.2. The Contestant who has completed the online entry form is eligible for the Prize (defined below) draws, to be held no later than Monday, May 16th, 2022. Limit of one (1) Contest entry per person.

3. PRIZE

3.1. The Prize offered must be accepted as awarded and is not exchangeable, refundable, transferable or convertible into cash. In the even the Prize is not accepted in accordance with its attached conditions, the Prize will be deemed to be forfeited.

4. DRAW

4.1 One (1) random draws will be held from all eligible entries received after the Contest Opening Date and before draw date (previous day, 11:59 p.m., EST). The draw shall be held no later than Monday, May 16th, 2022 at 12:00p.m., EST, in the offices of Grafton Apparel, 44 Apex Road, Toronto, ON M6A 2V2.

5. PRIZE CLAIM

5.1 In order to be declared a winner, the selected Contestant must:

5.1.1 Fill in the entry form and complete and answer all the compulsory fields;

5.1.2 Be reached by telephone or email by the Organizer of the Contest within forty-eight (48) hours after the draw and correctly answer the mathematical skill-testing question that will be asked. If it is impossible to reach the selected Contestant by telephone or email within forty-eight (48) hours after the draw, all rights to the Prize will be forfeited and another entry will be drawn. If it is impossible to reach the second selected Contestant by telephone or email within forty-eight (48) hours of the draw of the second entry, all rights to the Prize will be forfeited and another entry will be drawn. If it is impossible to reach the third selected Contestant by telephone or email within forty-eight (48) hours of the draw of the third entry, the prize will be forfeited;

5.1.3 Complete and sign the declaration and waiver form (the "Declaration Form") which will be transmitted by the Organizer and must be returned to the Organizer of the Contest within three (3) business days of receipt.

5.2 The winner will be named within thirty (30) days following the draw date for the Prize.

5.3 In default of observing any of the conditions mentioned above or any other conditions stipulated in these Rules, the selected Contestant will be disqualified and the Prize that would have been awarded will be forfeited. Within the days following receipt of the duly completed Declaration Form, the Organizer of the Contest will contact the winner to inform him/her of how to claim the Prize.
