"WIN A TRIP TO PARIS, FRANCE" CONTEST RULES (the "Rules")

Under the "Win A Trip to Paris, France" Contest (the "Contest") organized by George Richards ("Organizer") doing business as Grafton Apparel ("Grafton Apparel") and taking place between Wednesday, March 1, 2023 at 08:00 am EST and, Monday, June 5, 2023 at 07:59 a.m. EST, the undersigned (the "Winner") will be chosen at random in a draw that will be held no later than Monday, June 19, 2023.

1. ELIGIBILITY

The Contest is open to all residents of Canada (excluding the province of Quebec) who have reached the age of majority in their province or territory of residence by the Contest Opening Date, except for employees, agents and representatives of the Organizer, its subsidiaries, affiliates, affiliated companies, advertising or promotion agencies, the suppliers of material, prizes and services related to this Contest, and any other stakeholder directly related to the holding of the Contest, as well as the members of their immediate family (father, mother, brothers, sisters, children and legal or de facto spouse) and anyone with whom these employees, representatives and agents reside.

2. HOW TO ENTER

2.1. No purchase necessary

2.1.1. To enter the Contest, the contestant (the "Contestant") must fill out the form on contest application available at <u>www.georgerichards.ca/contest</u> and provide the following mandatory information: (i) first name; (ii) last name; (iii) email address; (iv) phone number; (v) address; (vi) date of birth to confirm that he/she has reached the age of majority in his/her province; (vii) that they have read and understood the contest rules and (viii) agrees to receive marketing emails from Tip Top, before the Contest Closing Date, to be automatically entered.

2.1.2. The Contestant who has completed the online entry form is eligible for the Prize (defined below) draws, to be held no later than Monday, June 19, 2023. Limit of one (1) Contest entry per person.

3. PRIZE

3.1. The Winner hereby acknowledges and accepts the Prize consisting of flight transportation for two (2) adults, five (5) night hotel stay, and five hundred dollars (\$500) CDN for spending, offered by George Richards, worth a maximum value of \$6,000 CAD. Booking to be made at the discretion of Grafton Apparel. This prize includes:

- A roundtrip economy-class airfare from an airline of our choosing, from the Winner's city of residence to Paris, France.
- Five (5) nights stay in one (1) room for two (2) adults, at a hotel of our choosing
- Five hundred dollars (500) CDN

Any expense not mentioned above shall be borne exclusively by the Winner and his/her Travel Companion (as defined below).

4. CONDITIONS ATTACHED TO THE PRIZE

4.1. The Winner's travel companion has been designated as the person who will become the travel companion of the Winner for the purposes of the Prize (the "Travel Companion") and shall be a Canadian resident who has reached the age of majority in his/her province of residence by May 31, 2023.

4.2. The Winner and his/her Travel Companion must travel together both ways. Travel arrangements will be made by Grafton Apparel. The trip must be completed before November 30, 2024 ("Travel Deadline").

4.3. The following black-out dates apply: Holiday Season: from December 23, 2023 to January 06, 2024; March 11 – 17, 2024.

4.4. The reservations are subject to the availability of the air carrier and the hotel at the time of the reservation. The terms and conditions of the air carrier and the hotel are applicable. Taxes, airport fees, custom duties, entry fees and tourist cards, surcharges, insurance charges, vaccination expenses, any personal expenses, personal travel insurance and travel documentation are not included in the Prize and are solely the responsibility of the Winner and his/her Travel Companion.

4.5. On the travel date, the Winner and his/her Travel Companion must have the legal right to leave Canada and to return to Canada and must have the legal right to enter and leave the country of travel (as chosen by the Winner). The arrangements related to the package reservations must be made by Grafton Apparel on the date agreed by the Winner at least sixty (60) days before departure, September 30, 2024 at the latest, and will be subject to the availability of the air carrier and the hotel at the time. Once the booking is confirmed, fees of \$250 per person will apply for all change requests made more than four weeks before departure. No changes will be permitted within 30 days of departure.

4.7. The Prize offered must be accepted as awarded and is not exchangeable, refundable, transferable or convertible into cash. In the event that the Prize is not accepted in accordance with its attached conditions, the Prize will be deemed to be forfeited.

4.8. Grafton Apparel and all of its respective partners, shareholders, directors, officers, owners, associates, employees, members, sponsors, agents, representatives, successors and assigns shall assume no liability of any nature whatsoever for any postponement, delay or cancellation of the flight or any other component of the Prize or any other transportation included in the Prize for any reason whatsoever, including, without limitation, weather conditions or equipment breakdown or failure. In this regard, the Winner hereby waives all claims, whether past, present, future or contingent, against Grafton Apparel and all of its respective partners, shareholders, directors, officers, owners, associates, employees, members, sponsors, agents, representatives, successors and assigns relating to the subject matter hereof or relating, directly or indirectly, to any postponement, delay or cancellation of the flight or of any other component of the Prize or of any other transportation included in the Prize.

5. DRAW

- 5.1 One (1) random draws will be held from all eligible entries received after the Contest Opening Date and before draw date (previous day, 11:59 p.m., EST). The draw shall be held no later than June 19, 2023 at 12:00p.m., EST, in the offices of Grafton Apparel, 115 Applewood Crescent, Concord ON L4K 5C1.
- 5.2 The drawn name must be subscribed to the email database to qualify to be the winner.

6. PRIZE CLAIM

6.1 In order to be declared a winner, the selected Contestant must:

6.1.1 Fill in the entry form and complete and answer all the compulsory fields;

6.1.2 Be reached by telephone or email by the Organizer of the Contest within forty-eight (48) hours after the draw and correctly answer the mathematical skill-testing question that will be asked. If it is impossible to reach the third selected Contestant by telephone or email within forty-eight (48) hours of the draw of the third entry, the prize will be forfeited;

6.1.3 Complete and sign the declaration and waiver form (the "Declaration Form") which will be transmitted by the Organizer and must be returned to the Organizer of the Contest within three (3) business days of receipt.

6.2 The winner will be named within thirty (30) days following the draw date for the Prize.

6.3 In default of observing any of the conditions mentioned above or any other conditions stipulated in these Rules, the selected Contestant will be disqualified and the Prize that would have been awarded will be forfeited. Within the days following receipt of the duly completed Declaration Form, the Organizer of the Contest will contact the winner to inform him/her of how to claim the Prize.
