Please note that all notifications related to a transfer of ownership of animals listed on the Central Animal Records microchip registry must be made in writing. In addition, changes to the ownership records for the animal listed on this form, will only be made once the form and payment has been received, and all legal requirements have been met.

FEES: A \$15.00 fee applies to change ownership of a pet listed with Central Animal Records. Payment must accompany this form, & can be made by cheque or money order, made out to Central Animal Records, or by completion of credit card details (see below). Once processed, a Certificate of Identification reflecting these changes will be issued to the new owner. If the previous owner has not signed this form, the transfer can take up to 23 days as we are legally required to contact the previous owner for consent to transfer ownership. **Transfer fees are subject to change without notice.**
