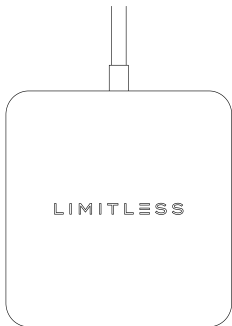
Safety Warnings

- The PowerPro 5-Device Charger is designed for indoor use only in dry locations. Use with aquariums **VOIDS** all warranties.
- The PowerPro 5-Device Charger is **NOT** a lightning arrester and will not protect against a lightning strike.
- Do **NOT** plug into another relocatable power tap.
- The PowerPro 5-Device Charger must be plugged directly into the power source and must **NOT** be “daisy-chained” together in a serial fashion with other power strips, UPS Battery Backups, surge protectors, or extension cords. Do **NOT** use AC adapters.
- The PowerPro 5-Device Charger is **NOT** a toy and should be kept away from children.
- Do **NOT** attempt to modify, disassemble, or repair the PowerPro 5-Device Charger or any of its features. Doing so will void the warranty.

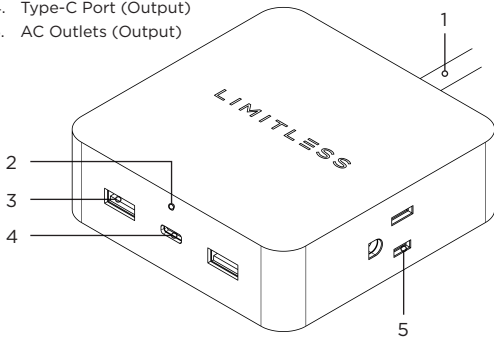

4. Type-C Port (Output)
5. AC Outlets (Output)



Operation Instructions

Using the PowerPro 5-Device Charger

Plug the 6ft Power Cable into an AC outlet. The LED Power Indicator Light will illuminate and the PowerPro 5-Device Charger is ready to use.

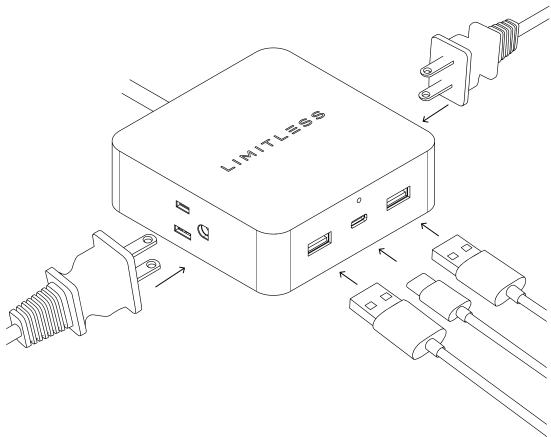
Connecting a Device

- A. Plug a corresponding charging cable into one of the Type-C or USB-A Ports on the front of the PowerPro 5-Device Charger and into the mobile device.
- B. Connect an AC plug into one of the outlets on the side of the PowerPro 5-Device Charger. There are 1280 Joules of built-in surge protection.

NOTE:

Charging times may vary by device. The PowerPro 5-Device Charger has a max total output of 40W. When multiple devices are connected, the PowerPro 5-Device Charger may, at times, reach its maximum charge capacity causing the connected devices to charge at a slower rate. If this occurs, remove a connected device to resume optimal charge.

As utilized herein, the term "PowerPro 5-Device Charger" (or the singular, Limitless product) shall include all products set forth above in the what's included section of this User Manual that may be sold by Limitless now or in the future.

This Limited Warranty is a consumer's sole and exclusive remedy regarding any express warranty claim by a consumer and is subject to the exclusions on the following pages:

Exclusions: The Limited Warranty shall not apply in the event of the occurrence of any of the following:

1. Normal Wear and Tear. The Limited Warranty shall not apply to cover the maintenance, repair and/or replacement of parts or the Limitless products due to normal wear and tear by the consumer.

Limited Warranty cont'd

2. Abuse and Misuse. The Limited Warranty shall not cover defects or damage that result in whole or in part from: (a) improper operation, storage, misuse or abuse, accident or neglect by the consumer (including, without limitation, physical damage, cracks and scratches to the surface of the Limitless product; (b) contact with liquid, water, rain, extreme humidity or heavy perspiration, sand, dirt or the like, extreme heat, or food; (c) use of the Limitless product for commercial purposes; (d) subjecting the Limitless product to abnormal usage or conditions; and/or (e) other acts which are not the sole and absolute fault of the Limitless product.

3. Unauthorized Service or Modification. The Limited Warranty shall not cover defects or damages resulting in whole or in part from service, testing, adjustment, installation, maintenance, alteration, or modification in any way by someone other than Limitless or its authorized service centers.

4. Altered Products. The Limited Warranty shall not cover defects or damages to a Limitless product with (a) serial numbers or date tags that have, at any time, been removed, altered, or obliterated; (b) broken seals or that show evidence of tampering; (c) mismatched board serial numbers; or (d) non-conforming or non-Limitless housings, or components.

5. Communication Services. Defects, damage, or the failure of the Limitless products due to any communication service or signal you may subscribe to or use with the Limitless product or software.
