I, the undersigned, authorize Agape Chic Consignment Boutique, Inc. to sell all or any portion of the items consigned according to the terms of this agreement for a consignment period of **60 days**.

I will receive **40% of the sale price**, when any item is sold during the consignment period. All items are subject to regularly scheduled markdowns occurring 35 days from the initial date of the consignment or at any time for promotional purposes per the discretion of Agape Chic Consignment Boutique, Inc. A small processing fee will be added to the price tag of each item. This fee is passed on to the buyer and will not be reflected on my inventory list.

An annual membership fee of \$12, which includes online access, will be charged to my account on the first consignment intake of each year. Account balances can be viewed and tracked online with consignors login ID @ www.agapechicboutique.com.

Upon the sale of the item(s), I will have the opportunity to use my earned funds toward a store purchase at any time, or for account balances over \$20, I can wait until the 15th of the following month to pick up a check at Agape Chic Consignment Boutique, Inc. My check will be available for pick up at any regular business hour, on or after the 15th. If the check is not picked up within 90 days from the date it is written, I understand I will lose that amount. Checks will not be mailed. If an account remains inactive for more than a year, then any balance remaining is forfeited.

All merchandise not sold during the 60 day consignment period and not reclaimed by me within five (5) days following the end of the consignment period, will become property of Agape Chic Consignment Boutique, Inc. **It is my responsibility to keep track of my pick-up date. I understand that Agape Chic will not contact me when my items are to be removed or retained.** Items may be donated, without notification, due to previously unnoticed stains, rips, odors, or other flaws.

I understand that item(s) brought into Agape Chic Consignment Boutique, Inc. must be authentic and in ready to sell condition; free of defects; on hangers, laundered or dry-cleaned.

I am the rightful owner of all merchandise left with Agape Chic Consignment Boutique, Inc.

I understand that if any item left with Agape Chic Consignment Boutique, Inc. is found to be counterfeit and Agape Chic Consignment Boutique, Inc. incurs any liability as a result of the sale of merchandise, I agree to indemnify, defend, and hold harmless Agape Chic Consignment Boutique, Inc., its shareholders, directors, officers, agents and employees for all damages, claims, or causes of action caused by any act or omission on my part. This provision shall include all costs and disbursements, including without limitation court costs and reasonable attorneys fees, and shall survive the termination of this Agreement.

I understand that Agape Chic Consignment Boutique, Inc. assumes no responsibility for loss or damage to merchandise and all items left are at my own risk.
