Cold remedy

Common cold agent 3 A

It is a medicine improving symptoms for cold.

The acetaminophen ethenzamide is alleviation of fever, analgesic effect

The methylephedrine hydrochloride chlorpheniramine maleate phosphoric acid dihydrocodeine noscapine for mucus, nasal congestion, a cough, the symptom of the sputum

The Glycyrrhiza powdered, bellflower powdered improves for swelling and the pain of the throat.

Must not do

(a current symptom worsens when we do not protect it, and a side effect, an accident becomes easy to occur)

1. The next person, please do not take it

- (1) The person who has had a hypersensitivity symptom (rash, redness, itch, edema) with this medicine.
- (2) The person who we took this medicine or other cold remedies, antipyretic analgesic, and has had asthma.
- 2. While you take this medicine, please do not take neither next pharmaceuticals
- The oral medicine which contains other cold remedies, antipyretic analgesic, a sedative, an antitussive expectorant, an antihistamine (medicine for oral medicine for rhinitis, motion sickness medicine, allergies)
- 3. After remedy, please do not do the control of a vehicle or the instrumentation
- (sleepiness may appear.)
- 4. Please do not drink at the remedy5. Please do not do long-term therapy

Caution

- 1. The next person, please talk with a physician or a pharmacist before remedy
- (1) The person who is treated by a physician or the dentist.
- (2) A pregnant woman or the person who seems to be pregnant.
- (3) The person whom we are nursing.
- (4) Milk, 幼, children (under 15 years old) whom or there is the suspicion who have varicella (chicken pox) or influenza.
- (5) Elderly people.
- (6) The person himself or a family is the person of the allergic constitution.
