Boyd Employee Scholarship Guidelines

1. Applicant must submit an application to the R.H. Boyd Family Endowment Fund.
2. Proof of acceptance from a school or workshop must be submitted to the Committee before the award is determined. The school, workshop, or training being applied to must be pertinent to the enhancement of R.H. Boyd and the perspective applicant must matriculate in a subject that will enhance his/her position with R.H. Boyd.
3. A transcript must be submitted to the Committee from the school the applicant last attended, if applicable.
4. The applicant must have the school send the Committee a transcript or comparable record of the applicant's grade point average at the end of each semester.
5. Application must be signed and submitted to the employee's Director.
6. Applicant must be currently employed full-time and have been employed at least two (2) calendar years by R.H. Boyd before applying.
7. The applicant must not attend classes during regular working hours.
8. A check will be sent directly to the school and solely applied towards tuition, fees, and required textbooks for the awarded amount.
9. Applicant must maintain at least a 3.2 GPA per semester while matriculating in school.
10. The application must be received by March 31, 2023.
11. The applicant must continue to work for company at least two (2) years after completing the program of study.
