

Boyd Undergraduate Scholarship Guidelines

- 1. Applicant must be a currently enrolled senior in high school for the spring 2022 semester.
- 2. Scholarship must be for the 2022-23 academic year.
- 3. Applicant must major in finance, business administration, journalism, theology, history, english, computer science, or related fields at his or her college or university.
- 4. Applicant must have a minimum 3.2 GPA on high school transcript. Official transcript is to be mailed to the office by the deadline.
- 5. Applicant must maintain at least a 3.2 GPA per semester while in college.
- 6. Applicant must agree to provide the Endowment Fund Committee with an official transcript at the end of each semester.
- 7. The initial awarding of the scholarship is not a guarantee of its continuance.
- 8. In the event of excess funds, the excess is to be returned to the R.H. Boyd Endowment Fund.
- 9. All scholarship monies are to be paid directly to his or her college or university.
- 10. Application must be received by March 31, 2022. If awarded funds will be available for the fall semester.
- 11. The scholarship recipient will be notified by May 31, 2022. Please provide an accurate email address.
- 12. Applicant must be prepared for an oral interview by telephone or in person by the Endowment Coordinator, or a designee from the committee.
- 13. Late, incomplete, or unsigned applications will be declared ineligible.
- 14. Scholarships are only provided for one year and must reapply each year.
- 15. Upon acceptance of a Boyd Scholarship, it is expected of you to give back to the Endowment Fund in some way to further its continuance for future generations. There are various ways to do so, either by writing articles for our monthly *Union Review*, doing an internship, working with our annual Vision Conference, or host information sessions on campus or virtually of promoting the importance of the R.H. Boyd Family Endowment Fund.
