

The R.H. Boyd Family Endowment Fund reserves the right at anytime, with or without notice, to modify, amend, and change the policies and rules of the R.H. Boyd Family Endowment Fund. Said modification, change, or amendment may operate retrospectively or prospectively as determined by R.H. Boyd Family Endowment Fund.

## **Boyd Undergraduate Scholarship Guidelines**

- 1. The applicant must be a rising Junior or Senior at an accredited college or university and be a full-time student, taking at least 12 hours.
- 2. Scholarship is for the 2024-25 academic year.
- 3. Applicant must major in finance, business administration, journalism, theology, history, english, computer science, or related fields at his or her college or university.
- 4. Applicant must maintain at least a 3.2 GPA per semester while in college.
- 5. Applicant must agree to provide the Endowment Fund Committee with a copy of their transcript, and at the end of each semester a copy of their grades in order to receive funds for the next semester.
- 6. The initial awarding of the scholarship is not a guarantee of its continuance.
- 7. All funds not applied to tuition and books are to be returned to the endowment.
- 8. All scholarship monies are to be paid directly to his or her college or university.
- 9. Applications must be submitted to the R.H. Boyd Family Endowment Fund and received in the office no later than March 31, 2024. If application is submitted electronically, it needs to be in the office by the close of the business day at 4:00 p.m. (CST). If awarded, funds will be available for the fall semester.
- 10. The scholarship recipient will be notified by May 31, 2024. Please provide an accurate email address.
- 11. Applicant must be prepared for an oral interview by telephone or in person by the Endowment Coordinator, or a designee from the committee.
- 12. Late, incomplete, or unsigned applications will be declared ineligible.
- 13. Scholarships are only provided for one year and must reapply each year.
- 14. Upon acceptance of a Boyd Scholarship, it is expected of you to give back to the Endowment Fund in some way to further its continuance for future generations. There are various ways to do so, either by writing articles for our quarterly *Union Review*, doing an internship, working with our annual Vision Conference, or host information sessions on campus or virtually of promoting the importance of the R.H. Boyd Family Endowment Fund.
