### Additional comments:

Fine fragrance – 0.01%

Eau de toilette - 0.004%

Fragrance cream - 0.002%

Rinse-off products - 0.001%

Other leave-on products and oral products - 0.0002%

\*Safrole as such should not be used as a fragrance ingredient; essential oils containing safrole should not be used at a level such that the total concentration of safrole exceeds 0.01% in the finished product.

The total concentration of safrole, isosafrole and dihydrosafrole should not exceed 0.01% in the finished product.
