

■ Features

- 1. Model Name: TC-073CH65
- Space saving, not only a wall charger also a power strip, more convenient for daily usage.
 With 1 HDMI Ports, 2-Quitlets, 2 USB-C PD Ports and 1 USB-A.
- Ports, charging 6 different devices simultaneously.
- HDMI supports audio/video input and output, up to 4K@60Hz HD data transmission (the monitor also needs to support 4K@60Hz display).
- This product is a 65W travel charger using a new semiconductor material (GaN) process.
- 6. Supports QC4+, PD3.0, QC3.0, QC2.0, SCP, FCP, AFC, PE+ and other features, the maximum output power of USB-C1/USB-C2 single port can reach 65W(20V==3.25A), which can provide the PD fast charging for most laptops, mobile phones, and tablets. The maximum output power of a single USB-A port can reach 60W(20V==3A), and it supports 22.5W SCP super fast charging.
- The product has built in multiple safety protection circuits such as over-current, over-voltage, and temperature protection.

■ How to Use

- 1. Plug the power supply into a 100-240V socket or power strip.
- Connect the male end of the USB-C (or A) cable to the female USB-C (or A) connector on the multifunctional charging station.
- Connect the terminal connector of the USB-C (or A) cable to your cell phone or electronic device then the multifunctional charging station starts charging your device.
- USB-C (or A) automatically identifies the device to adjust the output voltage and current to achieve fast charging.
- HDMI port helps the audio/video works directly by connecting the HDMI connector cable.
- 6. Please remove the TC-073CH65 multifunctional charging station from the socket or power strip if you do not need to use it.
