**Troy Duster** is Silver Professor of Sociology at New York University, and holds an appointment as Chancellor's Professor at the University of California, Berkeley. He served as chair of the joint National Institutes of Health/Department of Energy advisory committee on Ethical, Legal and Social Issues in the Human Genome Project. He is the past-president of the American Sociological Association (2004–2005). His relevant publications include *Cultural Perspectives on Biological Knowledge* (co-edited with Karen Garrett, Norwood; NJ, 1984), *Backdoor to Eugenics* (2<sup>nd</sup> ed, New York: Routledge, 2003), and *Whitewashing Race: The Myth of a Colorblind Society*, with M. Brown, et al. (Berkeley: University of California Press, 2003).

**Hiroki Oota** is Associate Professor at Kitasato University School of Medicine in Japan. He was awarded the Walter M. Fitch Prize of the Society for Molecular Biology and Evolution (SMBE) in 1995. From 1999 to 2001, he worked with Mark Stoneking in the Max-Planck Institute for Evolutionary Anthropology. He has been working on human (as well as non-human primates) population genetics, especially in East Asia. He is the coauthor (with W. Settheetham-Ishidab et al.) of 'Human mtDNA and Y-chromosome variation is correlated with matrilineal versus patrilineal residence,' *Nature Genetics*, 29: 20–21 (2001); (with T. Kitano et al.) 'Extreme mtDNA homogeneity in continental Asian populations,' *American Journal of Physical Anthropology*, 18 (2002); and (with B. Pakendorf et al.) of 'Recent origin and cultural reversion of a hunter-gatherer group' in *Public Library of Science (PLoS) Biology*, 3(3) (2005)

**Caroline S. Hau** is Associate Professor at the Center for Southeast Asian Studies, Kyoto University. Her books include *Necessary Fictions: Philippine Literature and the Nation, 1946–1980*; *On the Subject of the Nation: Filipino Writings from the Margins, 1980–2004* (Quezon City: Ateneo de Manila University Press, 2000) and *Intsik: An Anthology of Chinese Filipino Writing* (ed.) (Pasig City: Anvil Publishing, 2000). She is currently working on a book about the cultural politics of Chineseness in the Philippines and Southeast Asia.

**Midori Kurokawa** is Professor at the Department of Education, Shizuoka University. Starting from Japanese modern and contemporary history and the Taisho democracy, she has been researching minority issues, particularly the history of social thought and buraku history in Japan. Major publications include: *Between Dissimilation and Assimilation: The "Hisabetsu Buraku (Discriminated Hamlet)"* (Tokyo: Aokishoten, 1999, in Japanese); *The*

*Restitution of Community: A Study on Oyama Ikuo* (Tokyo: Shinzansha, 2000, in Japanese); and *Modern History of Buraku: From Meiji to Present* (Tokyo: Heibonsha, 2011, in Japanese).

**Lee Sung Yup** is Assistant Professor at the Institute for Research in Humanities, Kyoto University. After earning his BA (Korea University) and MA (the Academy of Korean Studies) in Korea, he received his Doctoral degree from Kyoto University. His main field is the political history of Japanese colonialism, especially the interrelationships among the political activities of Japanese residents in Colonial Korea, the Government General's reaction to such activities, as well as the collaboration and/or opposition of Korean elites. Major works include: *Kuratomi Yūzaburō Diary* vol.1 (co-author, Kokushokankōkai, 2010, in Japanese); and 'Was Emperor Kojong poisoned?', *Twentieth Century Studies*, 10 (2009, in Japanese).

**John G. Russell** is Professor of Anthropology at the Faculty of Regional Studies, Gifu University, Japan. His publications include *Japanese Perceptions of Blacks* (Tokyo: Shinhyoron, 1991, in Japanese); 'Consuming passions: Spectacle, self-transformation and the commodification of blackness in Japan,' *positions: east asia cultures critique*, 6:1 (1998); and 'The Other Other: The black presence in the Japanese experience' (in Michael Weiner (ed.) *Japan's Minorities: The Illusion of Homogeneity* (2<sup>nd</sup> ed., London: Routledge 2009). He is presently researching representations of race in contemporary US and Japanese science fiction.

**Ella Habiba Shohat** teaches Cultural Studies at New York University. She has lectured (nationally and internationally) and written extensively on issues related to Eurocentrism, Orientalism, Postcolonialism, and Transnationalism. Her award-winning publications include: *Taboo Memories, Diasporic Voices; Israeli Cinema: East/West and the Politics of Representation* (Durham: Duke University Press, 2006); and with Robert Stam, *Unthinking Eurocentrism; and Race/Coloniality in Translation* (forthcoming, New York: New York University Press). Her work has been translated into more than ten languages.

**Marvin D. Sterling** is Assistant Professor of Cultural Anthropology at Indiana University, Bloomington. His research interests center on race, performance, and cultural transnationalism in East Asia and the African diaspora. He is the author of *Babylon East: Performing Dancehall, Roots Reggae and Rastafari in Japan* (Durham: Duke University Press, 2010).

**Mark Stoneking** has, since 1999, directed the Molecular Anthropology Group within the Department of Evolutionary Genetics at the Max Planck Institute for Evolutionary Anthropology in Leipzig, Germany. He is also an Honorary Professor of Biological Anthropology at the University of Leipzig. Prior to going to Leipzig, he was on the faculty of the anthropology department

at Pennsylvania State University from 1990–1998, where he attained the rank of Professor. His research interests involve using molecular genetic methods to address questions of anthropological interest about human population history.

**Yasuko Takezawa** is Professor of Cultural Anthropology at the Institute for Research in Humanities, Kyoto University. Her research interests include race, ethnicity, and migration. Since 2001, she has organized a number of joint research projects on race, and currently she serves the head of the project, ‘A Japan-based Global Study of Racial Representations.’ Her major publications include *Breaking the Silence: Redress and Japanese American Ethnicity* (Ithaca: Cornell University Press, 1995); *Is Race an Universal Idea?: Beyond the Western Paradigm* (ed., Kyoto: Jimbun shoin, 2005, in Japanese); and *The Representation and Social Reality of Race* (ed., Tokyo: Iwanami shoten, 2009, in Japanese).
