

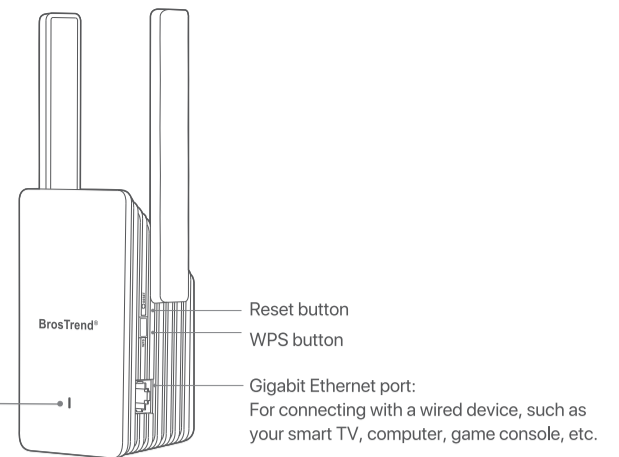

- Solid Blue:**
The extender/adaptor is in a proper position and receiving strong signal from your router.
- Solid Yellow:**
The extender/adaptor is receiving good signal from your router.
- Solid Red:**
The extender/adaptor is receiving weak signal from your router. Please relocate it closer to your router for better performance.
- Blinking Red Slowly:**
The extender/adaptor is powered on, while setup is not completed or fails to receive any signal from your router. Please relocate it closer to your router or set it up again.
- Blinking Blue Fast:**
The extender/adaptor is pairing with your existing router via WPS method. Please wait until the pairing completes.



Working Mode 1: Set Up as a WiFi Extender

1 Power on
Plug the extender into a power outlet in the same room as your existing WiFi router. Wait until the LED indicator blinks red slowly.

2 Connect to Your Existing WiFi Network

Method 1: Set up via Web Management Interface

1. Connect your WiFi device to the default WiFi network of the extender: **BrosTrend_EXT**, or connect your computer to the Ethernet port of the extender with an Ethernet cable.
2. Start a Web browser and visit brostreetwif.com or **192.168.0.254** in the address bar.
3. Create a login password for future logins. (Recommended)

* If the Web UI is inaccessible, refer to Q1 in FAQ.

4. Select **Extender Mode**, click **Next**.
5. Choose the WiFi network you want to extend and enter the WiFi password.
6. Customize the extended WiFi name (SSID) and password. Click **Extend**.
7. Check if the extender connects to your WiFi network successfully according to the status of the LED indicator.

LED indicator lighting solid on indicates a successful extension. You can connect to the following WiFi network to access the Internet.

- 2.4GHz WiFi Name: My_Home_WIFLEXT
- 2.4GHz WiFi Password: XXXXXXXX
- 5GHz WiFi Name: My_Home_WIFL5GEXT
- 5GHz WiFi Password: XXXXXXXX

LED indicator blinking red indicates the extension failed. Please connect to the following network to extend again.

- WiFi Name: BrosTrend_EXT

LED indicator lighting status:

- Solid blue: Strong signal
- Solid yellow: Good signal. Recommended to move the extender closer to the router
- Solid red: Weak signal. Please move the extender closer to the router for better performance
- Blinking red: Extension failed. Please connect to the WiFi network of the extender (BrosTrend_EXT) and set up again

Method 2: Set up via WPS button

* This method is applicable if your router has a WPS button. Otherwise, use Method 1.

1. Power on: Plug the extender into a power outlet in the same room as your existing router. Wait until the LED indicator blinks red.
2. Press the WPS button on your router.
3. Within 2 minutes, press the WPS button on the extender, the LED indicator on extender will start to blink blue fast.
4. Wait until the LED indicator turns solid on, which indicates a successful connection with your router.

* After the WPS pairing, for network security, please connect your wireless device to the newly extended networks and visit www.brostreetwif.com on a browser to set up a login password for your newly extended networks. **Otherwise, the Web UI will be open to any devices connected to the extended networks.**

The same as the WiFi password of your existing router.

3 Relocate

For optimal performance, please plug the extender into an electrical outlet halfway between your WiFi router and the WiFi dead zone.

The extender must be placed within the range of your WiFi router.

Keep your extender away from electronics with strong interference, such as microwave oven, induction cooker, and refrigerator.

LED indicator lighting status:

- Solid Blue: Strong signal
- Solid Yellow: Good signal
- Solid Red: Weak signal

Working Mode 2: Set Up as a Universal WiFi to Ethernet Adapter

1 Please refer to **Working Mode 1: Set Up as a WiFi Extender** to set up first.

2 Then connect your wired device to this adapter with an Ethernet cable. Setup completed!

***In this case, you need to configure the IP Address and DNS server address of your wired device as AUTO OBTAIN.**

Working Mode 3: Set up as a Wireless Access Point

We here set up on a mobile phone as an example. Actual setup steps on a desktop or tablet could be slightly different.

1 Power on
Plug the access point into a power outlet. Wait until the LED indicator blinks red slowly.

3 Connect to the Internet
Connect the access point to an Internet-enabled Ethernet port or LAN port of your router with an Ethernet cable. Setup completed!

Note:
* The LED indicator lighting solid blue indicates a successful Internet connection. Otherwise, refer to Q2 in FAQ to reset this access point and try again.

2 Create Your Wireless Access Point Network

1. Connect your WiFi device to the default WiFi network of this access point: **BrosTrend_EXT**, or connect your computer to the Ethernet port of this access point with an Ethernet cable.
2. Start a Web browser and visit brostreetwif.com or **192.168.0.254** in the address bar.
3. Create a login password for future logins. (Recommended)

4. Select AP Mode, click Next.

5. Customize the WiFi name and WiFi password, click Save, then wait for about one minute until the LED light blinks red slowly.

FAQ

Q1: I cannot log into the Web UI of the extender. What should I do?

- For initial setup, ensure your wireless device is connected to the default network of the extender: **BrosTrend_EXT**. Ensure that the **Mobile Data** (if any) function is disabled. If **BrosTrend_EXT** is not found, please refer to Q2 to reset the extender back to its default factory setting.
- If you have set up the extender successfully, you need to connect your device to the newly extended network of this extender and log into the Web UI.
- Verify that **brostrendwifi.com** is correctly entered in the address bar of your browser.
- Use another Web browser and try again.
- If you are using a wired device, such as a computer, ensure that your computer is set to **Obtain an IP address automatically** and **Obtain DNS server address automatically**.

Q2: How to reset the extender back to factory default setting?

- When the extender is fully powered on, press the **RESET** button with a needle-like object, the LED indicator starts blinking yellow fast.
- Wait until the LED indicator blinks red slowly, indicating the extender is reset successfully.

Q3: What should I do if I forget my login password?

- Please refer to Q2 to reset the extender first. Then connect to the default network **BrosTrend_EXT** and visit **brostrendwifi.com** to create a new login password. Please note down your login password for future logins.

Q4: The extender cannot find the WiFi network of my router. What should I do?

- Ensure the WiFi network of your router can be detected by other wireless devices.
- Change the WiFi channel of your router and try again.
- Change the encryption type of the router to **WPA-PSK/WPA2-PSK** or **WPA2-PSK/WPA3-SAE**, and try again.
