## 4. FIRST-AID MEASURES

## 5. FIRE-FIGHTING MEASURES

Suitable extinguishing media: Unsuitable extinguishing media:	Water spray, fog, CO2, dry chemical, or alcohol resistant foam. Do not use a solid water stream as it may scatter and spread fire.
