





### SYSTEM DESCRIPTION

This product is fully assembled and pre-plumbed as a 34 HP primary & 12 Volt backup sump pump system. The pumps are designed for use in residential applications to remove groundwater and prevent flooding. The pumps are designed for clear water only and not to be used with a portable generator. Installation of this system outdoors, unprotected from the weather, may cause hazardous conditions and will void warranty. Water inside the pump and plumbing may freeze, limiting the performance and damaging the pumps and plumbing. Uncontrollable environmental conditions can potentially cause damage to the unit and void warranty.

The AC pump is controlled with an innovative and reliable Air Switch, so the pump is no longer limited by the mechanical cycles of traditional float switch style pumps. The integrated controller and companion app for your iOS or Android device keeps you informed of the status of your pump; informing you whenever there is a problem and your basement is no longer protected. The battery backup pump has a controller mounted on the battery box with LED indicator lights to infrom you of the charge status of the battery and the incoming current from your home. The Air Switch technology does not monitor the DC pump, WAYNE recommends the WSB1275, 75 Amp-Hr maintenance free battery (sold seperately), to complete the





### **ROUTINE SUMP MAINTENANCE**

The pump should be inspected 3-4 times per year for pump movement or buildup of debris on the switch. Reposition pump if it has moved. Remove any debris that could interfere with the operation of the switch. Lack of proper routine maintenance will void warranty.

- Make sure the pump is plugged in to a working ground fault circuit interrupter (GFCI) outlet and the cord is in good shape.
   In damp areas, GFCI breakers may trip, effectively shutting off the sump pump. Check in on your sump pump and reset the GFCI if necessary.
- Ensure the pump is standing upright. Vibrations during operation can cause it to fall or tilt onto one side.
- Pour a bucket of water into the pit to make sure the pump starts automatically and the water drains quickly once the pump
- is on. If the pump doesn't start, have it serviced or replaced.
- Check the inlet screen and clear away any small stones or debris.

  Dielectric oil can be harmful to the environment. Follow state environmental laws when disposing of oil.
- 3. The AC pump motor is equipped with automatic resetting thermal protector and may restart unexpectedly. Protector tripping is an indication of motor overloading as a result of operating the pump at low heads, excessively high water temperature, excessively high or low voltage, inadequate wiring, incorrect motor conditions or at the end of its life.



- 3. Pump must be installed using 1-1/4 in. or 1-1/2 in. rigid PVC piping. Not exceeding 2' and no smaller than 1-1/4 in. to ensure proper operation.
- 4. Use a basin (purchased seperately) or pit that is large enough to accommodate the system. The minimum requirements for the sump system are:

- 5. Clean the basin/pit of all debris.
- 6. If using a basin, place the system directly on the bottom of the basin. To prevent damage set the system on a solid, level surface. Do not place units directly on clay, earth, gravel, or sand, A brick, sump liner, or blocks can be installed under the pumps to provide a solid base.
- 7. Install discharge plumbing according to local, regional and state codes, Rigid PVC pipe is required. Do not use flexible hose in a permanent application. Do not use schedule 20 couplings or drainage fittings.
- 8. Connect pump power supply cord to a ground fault circuit interrupter (GFCI) receptacle.

**NOTE:** Pump will initially run when plugged in to calibrate Air Switch.

NOTE: Do not pinch, strap, coil or constrict Air Tube.

- 9. Fill the basin/pit with water. The pump will activate when the water level has reached level 4 on the controller.
- 10. The pump will stop when the water level has reached the switch-off level.
- 11. Fill the basin/pit with water again. While the pump is draining the basin/pit, verify the discharge pipe is carrying the water to a point at least 3 ft. away from the foundation. If the discharge line is exposed to freezing temperatures, the pipe must be positioned in a downward slope away from the foundation so any remaining water will drain away and not freeze.

### **OPERATION**

# **A DANGER**

Always disconnect the power source before attempting to install, service, relocate or maintain the pump. Never touch sump pump motor, water or discharge piping when pump is connected to electrical power. Never handle a pump or pump motor with wet hands or when standing on wet or damp surfaces or in water. Fatal electric shock could occur.

### **A DANGER**

- 1. After installation, the backup pump will start when the water level rises above the backup float switch.
- 2. The control box has a DC charger designed to shorten the recharging time of your battery, and to prevent overcharging. In addition, the control box has a time delay which keeps the pump from repeated, short cycles when it shuts off. The time delay feature will allow the pump to run 20-25 seconds after the switch reaches the off position.
- 3. The control box contains multi-colored indicator lights. When AC power is present, the lights will indicate the charging state, and not reflect actual battery voltage, particularly with a defective battery. In order for the indicator light to provide an accurate reading, steps "a" through "d" must be followed.

a. After main pump and transformer are unplugged, a power off alert tone will sound for 30 seconds. The Power Failure Light should be illuminated.



- b. Press and release the self test button to activate the back up pump.
- c. When the pump stops, read the charge indicator lights: **Green:** Indicates the battery is fully charged. **Yellow:** Indicates battery partially charged, still operable. **Red:** Battery is completely discharged or defective. Red blinking: Battery discharged below level where pumping can occur. Motor is locked out by controller until battery is sufficiently charged to run pump.

**NOTE:** Repeat steps B and C 2-3 times to ensure battery health and pump operation.

d. Plug in transformer and main AC pump. The Power Failure light should go out.

When main AC power is out, and when pump has been running, the lights will indicate battery status.

- 4. A chirping sound from the control box will accompany the red light, indicating that the battery may require attention or replacement. Voltage is only an indicator of battery condition and may not reflect the true condition of the battery. See maintenance for instruction on assessing battery condition.
- 5. A single thirty (30) second tone will sound when power to the system is interrupted and the power failure light will illuminate. The unit will reset and the light will go out automatically when the power is restored.



6. A three (3) second tone will sound every time the pump starts.

- 2. Plug the float pump system, back up pump and transformer into the appropriate connectors. The connections are all unique and cannot be interchanged.
- 3. Put lid on box, and place the battery within six feet of the sump and a 115 VAC separately fused outlet. The outlet must be protected by a ground fault circuit interrupter (GFCI) The area must also be clean, dry and well ventilated.

# A CAUTION

Do not allow battery box to get wet, or expose it to moisture. Electronics will be damaged and void warranty.

### **BACK UP PUMP CHECK**

- 1. Unplug the AC main pump from the GFCI protected outlet.

- 3. Test system operation by filling the sump with water while the main pump is unplugged. If the pump operates properly, plug the transformer back into the GFCI protected outlet to begin charging the battery.
- 4. Protect electrical cord from sharp objects, hot surfaces, oil and chemicals. Avoid kinking the cord.
- 5. Secure power supply cord to discharge pipe using cable or zip ties to prevent possible switch entanglement.
- 6. After the backup pump check, secure the basin cover and gasket to the basin or pit to prevent debris from falling into the basin, prevent personal injury, and contain gases and/ or odors.

### **QUICK START GUIDE**

- 1. Carefully unbox your new STRATO system. Do not crimp, or puncture the clear air hose attached to the primary pump and controller. Inspect your air hose and pump for signs of damage that may have occurred during shipping.
- 2. Install the Basement Guardian mobile app on your phone. To find the app for your device visit www.basement-guardian.com on your phone and click 'Get The App' in the menu. Tap the ANDROID or iOS icon and you browser will open the corresponding app store
- 3. Install the app and create your account.
- 4. BEFORE YOU PLACE THE PUMP INTO YOUR SUMP PIT provision your smart pump. Plug the AC smart pump into a GFCI grounded outlet. The pump controller will light up and run
- 5. Open your basement Guardian APP and follow the instructions to "add a device". Select "HALO" and follow the instructions to provision the pump to your account.
- 6. Troubleshooting tips:
  - a. Make sure you have a strong Wi-Fi signal next to your sump pit.
  - b. If your phone is not scanning the QR code on the controller, move the controller back and then closer to your phone to help it focus. Conside using your phone's flashlight to increase visibility.
  - c. If you continue to have trouble scanning the QR code, take a photo of it and print it off on a printer. The increased size may make it easier for the phone to scan the code.
  - d. If your controller does not connect to your Wi-Fi make sure your router is running at 2.4GHz.
  - e. If you have a firewall, please be sure that your smart pump has permission to access your network. Consult your firewall provider and setting for more information.
  - f. If you are still having issues provisioning your pump visit our set-up troubleshooting article: bit.ly/3XnAh76
  - g. Your smart pump will protect your basement even if it is not provisioned to your Wi-Fi.
- 7. Once you have finished provisioning your smart pump, unplug it from the GFCI outlet, and proceed with physically installing the system in your sump pit, following the instructions in the user manaul.
- 8. When you plug your STRATO system back into the GFCI outlet the controller will automatically reconnect to your Wi-Fi network.
