This Beta Trial and Confidentiality Agreement (the "Agreement"), is effective as of today ("Effective Date") and is entered into by and between Empowerment Technology Inc., with offices at 2-590 York Rd, Niagara-On-The-Lake Ontario LOS 1J0 ("Empowerment Technologies Incorporated, known as ETI"), and You, an individual, serving as a beta trial participant ("You" or "Reviewer"), and relates to Your access to and use of one or more yet to be released Defender Sentinel Security System, or software identified in the beta trial sign-up, any and all content in and related to the Defender Sentinel Security System, related Software and related Services (collectively, the "Beta Trial").

# 2. Representations of Reviewer

By agreeing to this Agreement, You represent and warrant to ETI that (i) You have read this Agreement and the Rules of Engagement prior to accepting this Agreement and are fully familiar with the terms and conditions; and (ii) You have not, and will not in the future, enter into any agreement or understanding, whether written or oral, with any third party that impedes or conflicts with the performance of Your obligations set forth in this Agreement. If You do not so agree to the terms and conditions in this Agreement or if You cannot make such representations, You will not be permitted to participate in the Beta Trial.

#### 3. Your Role

In connection with the Beta Trial, and as further discussed in Section 4, below, You will provide feedback to ETI from the perspective of an end user consumer concerning the features or related elements of the Defender Sentinel Security System. You agree to perform such tasks as ETI shall direct related to the Beta Trial in a timely manner as requested by ETI. Neither party shall have the right, power, or authority to make any representation or warranty on behalf of, or to assume or create any obligation, whether express or implied, binding on, the other party in any manner whatsoever.

#### 4. Feedback

You acknowledge that ETI may request from You and You may provide to ETI, suggestions, feedback, commentary, ideas, concepts, inventions, characters, plots, titles, designs, art work, programs, programming techniques, or other statements (collectively, "Feedback") concerning the Defender Sentinel Security System or other Confidential Information. You acknowledge that all Feedback, expressly including but not limited to any and all patent, copyright, trademark, trade secret and other intellectual property rights related to the Feedback, is original, voluntary and automatically shall become the property of ETI and its designees. You acknowledge and agree that ETI shall be free to disclose and use Your Feedback as ETI sees fit without any obligation of any kind to You. You hereby assign and agree to assign ETI all rights, title, and interest in and to, and hereby waive and agree not to exercise any "moral rights" to, all Feedback provided to ETI that relate to the Beta Trial (including the Defender Sentinel Security System and Confidential Information). To the extent that ETI cannot claim exclusive ownership rights in all Feedback by operation of law or pursuant to the assignment noted above, and to the fullest extent permitted by law You hereby expressly grant to ETI and its licensors, licensees and designees a perpetual, irrevocable, worldwide, paid-up, non-exclusive, royalty-free, transferrable, sublicensable right and license to exercise all rights of any kind or nature associated with such Feedback in all formats and medium, whether existing now or in the future, and You agree not to assert or enforce any moral or similar rights You may have which may now or may hereafter be recognized, and all ancillary and subsidiary rights, in any languages and media now known or not currently known. #### 5. Nondisclosure of Confidential Information

You acknowledge that ETI, through the investment of significant time, effort, and expense has created the Defender Sentinel Security System and the related confidential information and that ETI is providing You confidential and/or proprietary trade information, intellectual property, business information or materials as part of the Beta Trial and that ETI wishes to maintain the confidentiality of its Confidential Information. As a material inducement to ETI to enter into this Agreement and to permit You access to participate in the Beta Trial, You hereby expressly represent and agree that You will not disclose, nor make any use of, or benefit from, directly or indirectly, the Confidential Information of ETI. This Section 5 and the terms below in this Section 5 will survive the termination of this Agreement.

(a) "Confidential Information" as used in this Agreement shall mean any and all information or material, of every kind and form, in electronic or tangible form, relating to the Beta Trial, the Defender Sentinel Security System or any other ETI products and services which are made available to You by ETI under this Agreement, whether or not designated as Confidential Information by ETI. Confidential Information includes, but is not limited to, all Feedback and all other information relating to the Beta Trial, Your selection as a Beta Trial participant, the Defender Sentinel Security System (including but not limited to information and ideas relating to the 4K Pro security camera, software, software code, designs, graphics, artwork, emails, screenshots, marketing emails, marketing and promotional plans, current, future or proposed

- (b) For the purposes of this Agreement, the term Confidential Information does not include information or material ETI discloses to You that You can demonstrate by written record (i) was known to You and in Your possession, without restriction as to use or disclosure prior to the disclosure by ETI; or (ii) is obtained, without restriction as to use or disclosure, from a source lawfully in possession of the information and having the right to disclose it without an obligation of confidentiality; or (iii) is independently developed by You (excluding Feedback) without use or knowledge of ETI's Confidential Information; or (iv) has been made publicly available by ETI.
- (c) You agree to hold in strictest confidence and not to disclose or reveal to any person or entity Confidential Information without the express prior written consent of a duly authorized representative of ETI. In particular, You must not discuss the Beta Trial with anyone associated with a competing Defender Sentinel Security System, any security camera developers, any news or information services (whether television, magazine, online, newspaper or otherwise), or review, report, monitor footage, online blog, or in any online forum or chat room, other than the official Beta Forum or specifically designated private ETI forum. Except as expressly authorized by ETI, You additionally agree not to use any of the Confidential Information for any purpose whatsoever or to disclose any of the Confidential Information at any time to any third party by direct or indirect means. - (e) Nothing contained in this Agreement shall be construed to create any obligation on the part of ETI to disclose any Confidential Information to You. ETI reserves the right to suspend, restrict, or cancel the Beta Trial, and/or may terminate Your participation in the Beta Trial at ETI sole and absolute discretion.

### 6. Limited License to Use

Subject to Your compliance with all of the terms and conditions in this Agreement and the Rules of Engagement, ETI grants to You, for Your personal and private use only, a nonexclusive, revocable, ETI Defender Sentinel Security System and firmware solely in connection with Your

participation in the Beta Trial. Upon the completion of the Beta Trial, if directed by ETI, you agree to uninstall or upgrade any firmware.

You agree that all intellectual property associated with or relating to the Beta Trial, the Defender Sentinel Security System, software, techniques, know-how, processes, and methodologies (including but not limited to test results, statistical information, and other information generated from or created during the undertaking of the Beta Trial) are and shall remain the sole and exclusive property of ETI. Except for the express license set forth above, nothing in this Agreement shall be construed in any way to grant You any license, right, interest, or expectation whatsoever, express or implied, under any patent, trademark, copyright, trade secret, know-how or technology that ETI may now have or hereafter have or generate relating to the Beta Trial or the Defender Sentinel Security System, this Agreement, other ETI products or ETI affiliates' products or property that may be disclosed hereunder. Nothing in this Agreement shall be construed in any way to create or confer a right, interest, or expectation of You in or to any tangible or intangible property or property right of ETI, or in or to any ETI information which may be disclosed by ETI to You. This paragraph will survive the termination of this Agreement.

You agree that ETI may terminate the Beta Trial and the license set forth above at any time, including without limitation, prior to the commercial release of the Defender Sentinel Security System. In addition, ETI may revise and change the Defender Sentinel Security System at any time during the Beta Trial. The restrictions and limitation in the Rules of Engagement will apply to the Beta Trial and Your use of the Defender Sentinel Security System.

# 7. Warranty

ETI will repair or replace (at our discretion) your product free of charge (not including shipping costs) for 12-months from the date of purchase, if the product is determined to be defective. A Sales Return Order Number is required from ETI prior to sending your Defender Sentinel Security System back for repair or replacement. Please visit the ETI Policies Page for more information about the process for claiming your warranty.

ETI may request you to return your product at any time during or after the beta trial for testing purposes. If this is requested, ETI will pay for all shipping and handling costs.

## 8. Remedies of ETI

The parties agree that Your obligations in Section 4, Section 5 and Section 6 of this Agreement are of a unique character and that the material breach of any obligation in such Sections by You will cause ETI irreparable injury. Therefore, ETI shall be entitled to immediate equitable relief to prevent such injury and/or damage. All remedies hereunder, and all remedies provided at law, shall be deemed cumulative and are not exclusive. This paragraph will survive the termination of this Agreement.

#### 10. Termination

If You do not agree to the current or revised terms and conditions of this Agreement, the Terms of Service, the Nondisclosure Agreement, the Privacy Policy, or the Code of Conduct, You should email ETI immediately at <a href="mailto:beta@etinc.ca">beta@etinc.ca</a> to discuss immediate termination of your Beta Trial participation.

## 11. Disputes
