In order to bring you the best possible show experience, management requests you review and agree to comply with the following rules for everyone's safety. By your signature on page 1 of this form

SAFETY: In consideration of the COVID 19 virus, Vero Beach Equestrian Club (VBEC) requires that all guests on the property wear a facemask and comply with social distancing recommendations. Additionally, we ask that spectators are kept to a minimum. We discourage spectators who do not have a family member riding in this competition.

THE BARN: Vero Beach Equestrian Club is a boarding facility, for the safety of VBEC boarded horses and VBEC staff, I ask that exhibitors please keep horses away from the stables so not to hinder barn operations. There is a wash rack available near trailer parking for exhibitors to wash their horses and obtain water.

RULES: Show attire is preferred, but not required......BOOTS and HELMETs are REQUIRED! HELMETS: All riders MUST wear an SEI approved helmet fastened and secured while mounted.

PAYMENTS: Upon receiving your entry form, Vero Beach Equestrian Club will send you an invoice. Please promptly pay your invoice and your entry will be complete. Entries without payments are incomplete and will not be accepted. Due to the high costs of preparing the venue, equipment, prizes and contracting a judge, VBEC asks that entries, coggins and payments **<u>BE RECEIVED BEFORE THE CLOSING DATE</u>** to guarantee your entry. Late payments may be assessed a \$25 late fee and Vero Beach Equestrian Club reserves the right to refuse late payments, cancel entries received w/out payment and/or cancel the show due to lack of entries.

LATE ENTRIES: Late entries MAY be accepted on a space available basis for a fee of \$25 per horse

FEES: <u>ENTRY FEES ARE NON-REFUNDABLE</u>. Even if you don't participate in the show, VBEC incurs expenses to hold the show (judge, prizes, insurance and other venue fees).

SCRATCHES: VBEC appreciates your entry in our show, however we request that exhibitors honor their commitment to financially support the show once the entry form & payment is sent. Show Management understands that sometimes emergencies do come up, and sometimes a scratch is inevitable... However, ENTRY FEES ARE NON-REFUNDABLE.

STALLS: Are not available.

COGGINS: As always, for the health and welfare of our equine athletes, show management requires proof of negative coggins as part of your entry package. Entries will be rejected without it. SHOW CANCELATION POLICY: Due to the high costs associated with holding a horse show, Vero Beach Equestrian Club's Show reserves the right to cancel the Show if less than 15 participants enter. Vero Beach Equestrian Club will refund any and all entry fees in the event of a cancellation.

SCHOOLING: Show Management encourages exhibitors to take advantage of the facilities for schooling the day of our show. However, riders/owners MUST check in with the administration booth to sign a liability waiver and/or get their show packages, upon arrival. Management MUST have an entry, signed liability release, proof of negative coggins, and payment, PRIOR to exhibitors (or ship in schoolers) riding their horse(s). If riders would like to ship in and practice the day before the show, please coordinate with VBEC as we do require reservations.

ADDITIONAL CONSIDERATIONS: the show jumping arena will be closed at 2:00pm the day before the show. Ship in "Schoolers Only" horses are welcome for venue fee of \$50 and must sign a liability waiver. However, <u>back numbers</u> <u>must be worn</u> at all times, when mounted. If back numbers are lost or misplaced during the show, please notify show management and a new one will be issued.

DOGS: Sorry folks, no dogs allowed.
