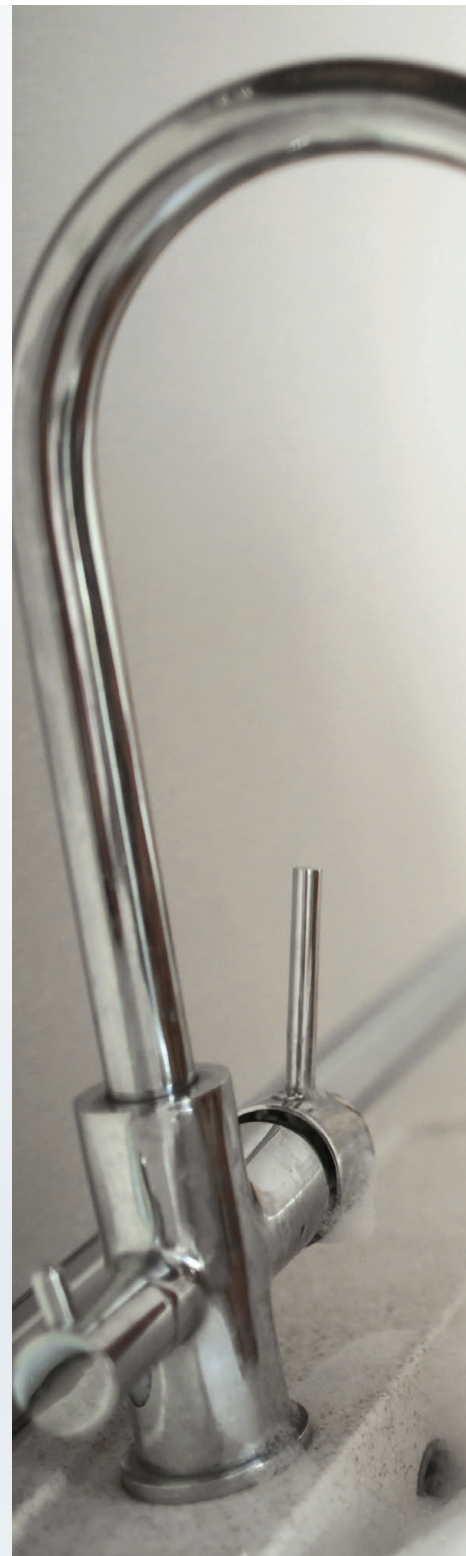

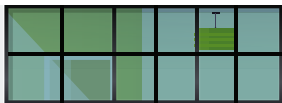

Water impurities vary widely by geography, the age and condition of municipal treatment plants, and other factors. Just a few common ones:



Lead. The U.S. Environmental Protection Agency (EPA) and the Centers for Disease Control and Prevention (CDC) agree — there's no safe level of lead in the human body, and it's especially damaging in children.



PFAS. Called the "forever chemicals," per- and polyfluoroalkyl substances (PFAS) are man-made substances that never break down — and a growing body of evidence associates them with adverse health effects.



Chloramine. According to Citizens Concerned About Chloramine (CCAC), this widely used water treatment chemical has not been adequately studied for health effects, which it says can include a variety of respiratory, immune system, skin, digestive and gastric, kidney and blood problems.
