Product Description

The Contro back to wall bath is manufactured from thermoformed Sanitary grade acrylic and reinforced with a fibreglass sandwich construction laminate. Drainage to the waste will be no less than a 1:50 gradient.

- The Contro is available in 1600x750mm & 1800x850mm sizes. The 1600x750mm size is available in straight back to wall, left hand and right hand versions. The 1800x850mm is only available as a straight back to wall. The baths include integrated side skirts and comes with a metal support frame with adjustable feet
- The bath can be factory fitted with 15mm Powder coated Aluminium upstands
