The Shower Door set is suitable for residential and commercial use. It is designed to fit Athena shower trays but can be used on tiled floors or other trays meeting the correct specifications. It is manufactured from Pre-finished Aluminium extrusions and grade A safety glass.

 - Rectangular: 1200x900 2 Sided and Alcove installations. (Soul only)
 - Angle Corner: 1000x1000mm.
 - Round: 1000x1000mm (Soul only)
 - Heights: 1920mm (Eclipse & Amara) & 2000mm (Soul)
 - Colour: Powder coat White, Anodised Satin
 - Doors: 6mm grade A safety glass. Return Panels- 5mm grade A safety glass

If the Door set is to be installed on a Athena shower tray with tiled walls the Door set must be installed directly to the water proof membrane to ensure fitment.

Only the Sealants provided by the manufacturer must be used in the installation
