THE WARRANTY

GAF warrants to you, the original owner of the building described above, that the United Coatings™ Aquathon® Wall Coating, United Coatings™ CanyonTone™ Clear Wall Coating, or HydroStop® FlexCoat Wall Coating (the "GAF Products") installed on an above-grade wall or other vertical application (the "Wall") will not contain a manufacturing defect that adversely affects their performance through the Expiration Date listed above as long as the GAF Products were installed during the shelf life set forth on the product label or container.

CONDITIONS TO WARRANTY COVERAGE

- Contractor:** The GAF Products must be installed by a GAF-certified roofing contractor in accordance with the current GAF published application instructions.
- Maintenance:** The owner must follow the GAF Maintenance Program provided with this limited warranty.
- Registration:** This limited warranty must be registered in accordance with GAF registration requirements.

EXCLUSIVE REMEDY

GAF's sole responsibility for breach of this limited warranty is the replacement material for that portion of the GAF Products that does not repel water as a result of a manufacturing defect or, at GAF's sole option, the cash value of said GAF Products. Decisions as to the extent of replacement products required will be made solely by GAF. The remedy under this limited warranty is available only for that portion of the GAF Products actually exhibiting defects at the time of settlement. The replacement GAF Products, as well as any remaining original GAF Products, will be warranted only for the remainder of the original warranty period.

NOTIFICATION OF CLAIM

In the event that you need to file a claim, you **MUST** notify GAF in writing — either by email (preferred) at guaranteeleak@gaf.com or by postal mail to GAF Guarantee Services, One Campus Drive, Parsippany, NJ 07054 — **and** provide proof of purchase, product name(s), lot number(s), and application date within **30 days** after your discovery of the leak. **NOTE:** Notice to your contractor or distributor is **NOT** notice to GAF. Within a reasonable time after proper notification, GAF will evaluate your claim and resolve it in accordance with the terms of this warranty. GAF may require you to submit, at your expense, samples of your GAF Products for testing and photographs. You should retain this document as well as the product name(s) and lot number(s) for your records in the event that you need to file a claim.

EXCLUSIONS FROM COVERAGE

This limited warranty does **NOT** cover anything other than lack of water repellency caused by a manufacturing defect, including but not limited to:

- Damages to the GAF Products resulting from anything other than an inherent manufacturing defect in the GAF Products, such as (a) faulty application or application that is not in strict accordance with GAF published application instructions; (b) exposure of the GAF Products to damaging substances, such as chemicals, oils, or solvents; (c) settlement, movement, moisture, or defects in the building, walls, foundation, or substrate material used as a base over which the GAF Products were applied; (d) defects in the design of the building; or (e) improper or inadequate maintenance.
- Damage to the GAF Products resulting from causes beyond normal wear and tear, such as (a) unusual weather conditions or natural disasters, including but not limited to, wind-driven rain, hail, floods, hurricanes, lightning, tornados, and earthquakes; or (b) improper storage or handling of the GAF Products.
- Any change in the color of the GAF Products, including, but not limited to, fading.
- Changes in the use of the building unless approved in writing in advance by GAF.

No representative, employee, or agent of GAF, or any other person, has the authority to assume any additional or other liability or responsibility for GAF unless it is in writing and signed by an authorized GAF Field Services Manager or Director. GAF shall not be responsible for any change or amendment to the GAF specifications used in the construction of your deck unless approved in writing by an authorized GAF Field Services Manager or Director.

This limited warranty **MAY BE SUSPENDED OR CANCELLED IF THE WALL IS DAMAGED BY** any cause listed above as AN EXCLUSION FROM COVERAGE that may affect the integrity of the Wall.

NON-ASSIGNABILITY

The limited warranty is **NOT TRANSFERABLE OR ASSIGNABLE** by contract or by operation of law, either directly or indirectly.

LIMITATION OF DAMAGES; MEDIATION; JURISDICTION; CHOICE OF LAW

THIS WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, and of any other obligations or liability of GAF, whether any claim against it is based upon negligence, breach of warranty, or any other theory. In **NO** event shall GAF be liable for any **CONSEQUENTIAL OR INCIDENTAL DAMAGES** of any kind, including, but not limited to, interior and exterior damages and/or mold growth.

The parties agree that, as a condition precedent to litigation, any controversy or claim relating to this warranty shall be first submitted to mediation before a mutually acceptable mediator. In the event that mediation is unsuccessful, the parties agree that neither one will commence or prosecute any lawsuit or proceeding other than before the appropriate state or federal court in the State of New Jersey. This warranty shall be governed by the laws of the State of New Jersey, without regard to principles of conflicts of laws. Each party irrevocably consents to the jurisdiction and venue of the above identified courts.

NOTE: Some states do not allow limitations on or the exclusion of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This limited warranty gives you specific legal rights and you may also have other rights which vary from state to state.

NOTE: This limited warranty becomes effective only when all the bills for installation and supplies have been paid in full to the contractor and materials suppliers, and the warranty charge has been paid to GAF.

This limited warranty must have a raised seal to be valid.
