

## Faucet Warranty

KIBI products are manufactured under the highest standards of quality and workmanship. KIBI extends this warranty to the original purchaser for personal household use of the "Faucet" in its original location. The warranty is non-transferable.

KIBI warrants the structure and finish of the product to be free from defects in material and workmanship under normal usage for the lifetime of the product. The warranty commences from the initial date of purchase by the owner or trade professional, from an authorized KIBI dealer, through the lifetime of the original owner or end-user.

KIBI warrants the mechanical component (cartridge) of the product to be free from defects in material under normal usage for a period of five (5) years. The warranty commences from the initial date of purchase by the owner or trade professional, from an authorized KIBI dealer, through the five (5) year term of the original owner or end-user.

Any product reported to the authorized dealer or to KIBI as being defective within the warranty period will be repaired or replaced with a product of equal value at the option of KIBI. This warranty extends to the original owner or end-user, and is not transferable to a subsequent owner.

## Restrictions

This warranty does not cover antediluvian, discontinued, or display products, whether such items are purchased at discount outlets, unauthorized dealers, and/or sold on clearance.

This warranty does not cover instances of negligence, misuse, abuse, improper installation, carelessness, accident, hard water or mineral deposits, exposure to corrosive materials, misapplication, damages caused by improper maintenance, alteration of the product, or failure to follow care or installation instructions enclosed with your product. Avoid using abrasive cleaners such as powders, bleach, ammonia, alcohol, or chlorine. Avoid using abrasive pads, steel wool, or wire brushes, as these will damage and wear down the finish.

This warranty does not apply to Products that have not been installed or operated in accordance with instructions supplied by KIBI and all applicable rules, regulations, and legislation pertaining to such installations.

This warranty does not apply unless the KIBI product is installed by a fully insured and licensed trade professional. KIBI insists that such professionals have experience in the installation of bathroom and kitchen manufactured goods.

This warranty does not cover labor charges or costs of removal and reinstallation of said product. This warranty does not allow recovery of incidental or consequential damages, such as loss of use, delay, property damage, or other consequential damages, and KIBI accepts no liability for such damages.

This warranty does not cover Marine or Outdoor Installation.

Except as otherwise provided above, KIBI makes no warranties, expressed or implied, including warranties of merchantability and fitness for a particular purpose, or compliance with any code.

Shipping charges will be covered for the first (1) year of the warranted replacement part or product (HI, AK, and Puerto Rico shipping charges may apply). International shipping fees are not included.

## Commercial Warranty

KIBI extends the above warranty for a period of one (1) year to purchasers of products for industrial, commercial, and business use.

All incidental or consequential damages are specifically excluded. No additional warranties, express or implied, are given, including but not limited to any implied warranty of merchantability or fitness for a particular purpose. Some states do not allow the exclusion or limitation of incidental or consequential damages or limitations on how long an implied warranty lasts, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

## Kitchen sink warranty

This product has been manufactured and inspected to the highest possible quality standards. Kibi sinks carry a limited lifetime warranty for residential use.

Should you experience any defects in materials or workmanship within the warranty period, we will repair or replace the defective product, subject to the following conditions:

- Any claim made under this warranty must include a copy of a valid proof of purchase showing the date and place of purchase.
- Our obligation under this warranty is to the original purchaser only, and may not be transferred.
- Product replacement does not include shipping costs or labor installation costs.
- This warranty applies to residential installations only.
- Kibi reserves the right to examine product in question and its installation prior to replacement.
- If an identical replacement product is not available, Kibi reserves the right to replace the defective product with a similar product.

**NOTE:** Accessories such as rinse grids, cutting boards, strainers are not covered by this warranty.

This warranty relates to defects in manufacture, materials or workmanship in a Kibi stainless steel kitchen sink supplied for installation into domestic premises in the United States. It does not extend to :

- Damage resulting from failure to maintain the product in accordance with the Care and Maintenance instructions in this manual.
- Normal wear and tear, scratches or accidental damage.
- Faults arising from improper use and/or installation.
- Defects in accessories, strainers and rinse grids.

**All incidental or consequential damages are specifically excluded. No additional warranties, express or implied are given, including but not limited to, any implied warranty of merchantability or fitness for a particular purpose.**

**Mechanical warranty:** A limited lifetime warranty is provided on all mechanical parts to be free from manufacturing defects in materials and workmanship under normal use for as long as the original purchaser owns their home.

**Finish warranty:** A 1-year warranty is provided on all KIBI Accessories to the original purchaser against manufacturing defects in materials and workmanship.

At its sole discretion, KIBI will repair or replace any part or finish that proves to be defective in material and/or workmanship under normal installation, use and service.

This warranty is extended to the original consumer owner, but does not cover installation or any other labor charges. In no event shall KIBI be liable for any incidental, consequential or special damages, installation cost, labor, travel time, freight costs incurred, lost profits, or contingent liabilities.
